It does not seem that long ago when I was so blind and self-righteous. As long as we see ourselves living and doing the best that we can, we are under the law of "I've got to be a good person." Now we sure don't want to be evil, but hidden u nder all this self-goodness is law, law, and more law. It seems so backwards, but the truth is, the more law, the more we sin. Because, the "Strength of sin is the law" (I Cor. 15:56).

The New Covenant has but one law. The Bible calls it the "Royal Law," the law of love: love God, love neighbor, and lov e yourself. When all this responsibility to love unconditionally falls on us, our hearts sink; for we honestly must admit to f ailure. We simply cannot love. Yet, why did we think we should try to be like Christ anyway? We would have to be God t o love that way. That is the point! Only God Himself can selflessly love.

What we don't understand is that our human vessel hasn't the capacity to love unconditionally. We were created to cont ain Mr. Love, Himself; but we were not created to produce it. Love is not a commodity to get, it's not a "how to" self-impr ovement program or an earned achievement. LOVE is a Person. We humans contain, not produce. When we discover t hat we are radically replaced by Christ, that "We don't live any longer, Christ lives in us," then we know we live by receivi ng, and not by achieving.

Freedom means that we are free to, or free not to, because we are led by the Spirit of God. "For as many as are led by t he Spirit are the sons of God" (Rom. 8:14); therefore, all the "I should's" and "I ought to's" of the law have no more claim on us. We are "dead to the law" in order that we can be married to another who raised us up from the dead, even our Lo rd Jesus Christ (Rom. 7:4).

As long as you see yourself alive and separate from Christ, you will make a law out of most anything. That is why freedo m only comes when you know you are "dead" and crucified with Christ and no longer live; then we know its Christ living in us and manifesting Himself as us.

Romans 6 is a freed self. "Freed" - not "free," made free by identification by faith with His death. A freed self. It says so h ere in verse 7. "He that is dead is freed from sin." We are freed selves in Christ's death and burial. But that's not the end of it. Oh, no, you come bang up against another problem in chapter 7. Now I'm a freed self, dead indeed unto sin, alive u nto God in my Lord Jesus Christ. Now I get about it; now I serve the Lord. Shall I? Bang, I go down again in Romans 7, because Romans 7 says, "Do it then, try it out. Here you are; here are the standards. Serve Him, fulfill His law, try it out." Bang, bang, bang, down you go again because we've to learn the second lesson which is our helplessness - OUR HELP LESSNESS. And the heart of Romans 7 is verse 18, the last half, "for to will is present with me, but how to perform that which is good I find I haven't the power." So the lesson we have to learn next is this: Yes, you are a freed self, but thoug h redeemed, still a helpless self. Romans 6 is a freed self. Romans 7 is a helpless self.

Now we are back in the garden of Eden. Now we are back in the very lesson which Adam failed to learn-his helplessnes s. The very lesson that Israel failed to learn at Mt. Sinai, was their helplessness. Now we have to learn it all over again. The redeemed self cannot do it, the redeemed self is merely a container that can't do a thing, "in me, in my flesh dwellet h no good thing." It's merely a container. It's a free container now. It's no longer a bound container, it's freed-free from si n free from the world, but it's still only a container. And if you up and try to serve Jesus, down you come again. You can't

The law was my "PERSONAL TRAINER," TEACHING ME THAT I LIVE BY RECEIVING, NOT BY ACHIEVING.

Every time I tried to be good or avoid evil - bang! The law would shoot me and down I would go. I would do this and not do that - Bang!

I would make new promises - redouble my efforts - Bang!

This time I would get hold of "God's Power" and do it right. - Bang!

This time I will be better "FOR SURE" - BANG!

Bang - bang - bang - I was shot down thousands of times before I even started to learn my lesson OF COMPLETE HEL PLESSNESS.

I could have never learned this so important lesson if the law did not shoot me. I now thank God for the law and all the bullet holes it put in me. Only the law could slay me of this self righteousness that I had. I had no idea that it even existed before the law shot me. It was the law the showed me that my "I" needed to replaced with Christ Himself.

Are you trying to add Jesus Christ to your life? Are you trying to apply His teachings to your life? This is NOT TRUE CH RISTIANITY! You do not apply Him or His teachings to your life at all. You have died and you have His LIFE. He applies HIs Life to you and in you - it was an total exchange. You died - He lives. You no longer have a life - He is your LIFE!

Gal 2:20, "I am crucified with Christ: neverthless I live; yet not I, but Christ liveth in me: and the life which I now live in the e flesh I live by the faith of the Son of God, who loved me, and gave himself for me."

Now look at this part, "yet not I, but Christ liveth in me." the "I" was replaced with the person of Christ. So the old you that t was servant and slave of sin was crucified and buried with Christ. When Christ arose from the dead - the new you was raised with HIM - with HIS LIFE.

Now the truth is that you are not separated from Christ. You just do not have Christ but Christ Himself is NOW you!!!! Yo u have died and Christ Himself is your life. This was an exchange of lives - not a change. Your old life was taken away in death and buried. Then Christ gave you His life in the place of your old life. Brethren respectfully I find this title troubling. At the risk of sounding heretical. I do not agree with the Puritan/Calvinistic idea that the law must be preached to plow up the heart to bring one to Christ.

Consider the words of Jesus in John 16:8-10

... And He (the Holy Spirit), when He comes, will convict the world concerning sin and righteousness and judgment; concerning sin, because they do not believe in Me; and concerning righteousness, because I go to the Father and You no longer see Me; and concerning judgement, because the ruler of this world has been judged...

Jesus is inferring that since we are under the New Covenant and the Holy Spirit is the dynamic of the New Covenant. It will be the Holy Spirit that will convict one of their sins.

If we want to see how God deals with sin. Then let us not go to the Mosaic law on Sinai. Let us not preach the law of M oses. But let us preach the cross. Indeed Paul opens up the first chapter of Corinthians by saying he preach nothing but Christ crucified. He preached nothing but the cross. For here we see how God deals with sin.

I have recently been meditating on the hymn, Stricken, Smitten, and Afflicted. I think these words by Thomas Kelly illust rate far more eloquently what I'm trying to convey.

"Ye who think of sin but lightly, Nor suppose the evil great, Here maybe it's nature rightly, Here is guilt make estimate. Mark the Sacrifice appointed, See who bears the awful load, Tis the Word the Lord's anointed, Son of Man and Son of God.

Brethren point a sinner to the cross for both conviction of sin and for salvation in Christ.

Normally I shy away from confessions of faith. But I found these two articles from the first London Baptist confession of 1 646 to be right on. For they depict a New Covenant emphasis on the preaching of the Gospel.

Artcle XXIV or 24

Faith is actively begotten by the preaching of the Gospel, of the word of Christ, without respect to any power or agency in the creative, but being wholly passive and dead in trespasses and sins, doth believe and is converted by no less power than that which Christ raised from the dead.

Article XXV or 25

The preaching of the gospel by the conversion of sinners, is absolutely free; no way requiring as absolutely necessary, a ny qualification, preparations, or terrors of the law, or preceding ministry of the law, but only alone and the naked soul, a sinner and ungodly, to receive Christ crucified, dead and buried, and risen again, who is made a Prince and a Saviour,

for such sinners as through the gospel shall be brought to believe on Him.

Working through the quaint 17th century language. Tis sufficient to preach Christ crucified and Him alone for the convers ion of sinners. One need not preach the law. But only preach Jesus.

Read Romans 1-8

Paul spends the first two chapters proving without argument that all are under sin. Much of Jesus teaching was spent proving all are under sin.

The Ray Comfort style of using the Law to prove all are under sin is very affective.

The issues arises when we confuse the law with the Gospel and people start believing that the Gospel is surrender to the law.

Tuk in the scriptures you quoted I believe Paul is speaking more from his experiences as a Jew who was under the law. The law was given to the Jews only. It had no reference to the Gentiles.

In reading through Acts one will see that Paul will use the Old Testament in dealing with Jews. The Jews would know the Old Testament promises would point to a Messiah. Thus it would make sense that Paul would reference Moses and the prophets to preach Jesus.

But Paul would take a different approach with the Gentiles. We see this as Paul was preaching to the Greeks in Athens. In this case Paul took something the Athenians knew which was the phrase to an unknown God. And launch a sermon p ointing to Jesus. Other times he would do miracles which would autheticate his gospel message. This happened when Paul confronted the Jewish false prophet bar Jesus in front of the Roman proconsul. In this case the proconsul was ama zed at the power or the teaching of Jesus. And this resulted in his conversion.

It is interesting that many Muslims are coming to Jesus Through dreams and Visions without the preaching of the law. Al I'm saying brother is that under the New Covenant we don't need to preach Moses. But we preach Jesus and the Spirit draws them.

Granted there are those preachers who preach the Ten Commandments as a means to plow up the heart. Open a sinn er up to the terrors of hell Then these preachers will present Christ to them. Tell the sinner they are saved by grace. And then point them back to the law as a means of obedience. Then these poor souls are certainly condemned to a Romans

7 experience. At least this was my experience when I was involved with Calvinism. Particularly among the Presbyterians and Reformed Baptists.

Eventually God did deliver me through His grace and pointed me in the direction of the cross and the New Covenant. Als o the Lord showed me that my heart was governed by the Holy Spirit and not by Moses. In other words it is Jesus who d wells in my heart and not Moses.

Brothers if anyone knew the law it was certainly the Apostle Paul. And he certainly knew what the law can do to a sinner given his experiences of Romans 7. However to the best of the apostolic record that is found in Acts, there is no indicati on that Paul ever preached the law to the Gentiles. At least a preaching the law to drive them and Christ.

Two accounts I reference. The first one is found in Acts 13 regarding Sergius Paulus. When Paul had the encounter wit h Elymias the Jewish false prophet. Paul rebuked Elymias and told him he would be blind for a time. Paul did this becau se Elymias was perverting the gospel that Paul was seeking to share with Sergius Paulus. Acts 13:12 says,

... Then the proconsul believed when he saw what had happened being amazed at the teaching of the Lord...

As far as we glean from the text there was no preaching of the Ten Commandments. But certainly a demonstration of the power of God. Such a demonstration that resulted in Sergious Paulius becoming a believer in Jesus.

The second account I references is found in Acts 16. An account we all are familiar with. In this case Paul and Silas had been imprisoned in Phillipi. At midnight when they were singing hymns of praise to God a powerful earthquake occurred. All the doors of the prison were opened. The Philippian Jailer thinking the prisoners had escaped was preparing to com mit hari-kari. Paul stayed his hand by reassuring the jailor all the prisoners were there. Consider the following verses ou t of Acts 16:30-31

... "Sirs what must I do to be saved?" They said, "Believe in the Lord Jesus and you will be saved, you and your househ old."

The law did not need to be preached. A demonstration of the earthquake power of God was enough to turn the Philippia n Jailer and his family to Christ.

I reference the above two accounts out of Acts where Paul preached Christ crucified as a result of the power of God bei

ng demonstrated. As far as I can see no law preaching was involved in the above two accounts.

Consider again what Paul says in Romans 15:18-19,

...For I will not presume to speak of anything except what Christ has accomplished through me, resulting in the obedienc e of the Gentiles by word and deed, in the power of signs and wonders, in the power of the Spirit so that from Jerusalem and round about as far as illyricum I have fully preached the gospel of Christ..

Again Paul is preaching in the power of the Spirit to the Gentiles to see them come to Christ. His message is confirmed and authenticated by signs and wonders. Paul is doing what Jesus said in John 16 when He testified that it is the Spirit t hat convicts of sin judgment and righteousness. This is New Covenant preaching that brings people to Christ. This is n ot the preaching of law. But this is the preaching of the Gospel by the power of the Holy Spirit.

Muslims are coming to Christ through dreams and visions. Muslims will not be drawn to Christ throigh the preaching of the Ten Commandments. But they will be drawn to Christ buy a vision of Jesus. Again this is New Covenant preaching.

When the centaurian, who was standing right in front of Him saw the way he breathed this last, he said, "Truly this man was the son of God."...

Here we see a Roman Centurion looking at Christ on the cross and acknowledging that He is the son of God. Again ther e was no law preaching. But be holding the Lamb of God that was taking away the sin of the world.

Consider also Luke 23:39-43. The account is familiar to us all. It is the account where the thief on the cross rebukes the other thief for reviling Jesus. The thief realizes his sinfulness by seeing Jesus dying on the cross. He says Jesus Reme mber me when you come into your kingdom. Jesus tells him today you will be with me in Paradise.

Here we see two examples where to men were brought to faith in Jesus Christ by beholding the Lamb of God being slain on the cross.

Paul is describing himself as a servant of the New Covenant. Paul is describing himself as a servant of the Holy Spirit. The law is old Covenant given to Israel. Paul does not use the law to preach to Gentiles to bring them to Christ. But he operates in the power of the Holy Spirit. This is because Paul sees himself as being under the New Covenant, being under the dynamic of the Holy Spirit.

Again please consider 2nd Corinthians 3:7-11,

... But if the ministry of death, in letters engraved on stones, came with glory, so that the sons of Israel could not look int ently at the face of Moses because of the glory of his face, fading as it was, how will the ministry of the Spirit fail to be ev

en more with glory? For if the ministry of condemnation has glory, much more does the ministry of righteousness aboun d in glory. For indeed what has glory, in this case has no glory because of the glory that surpasses it. For if that which fa des away was with glory, much more that which remains is in glory...

Bottom line the glory of the Old Covenant has passed away. We are under the glory of the New Covenant. We are gover ned by the Holy Spirit. Not by Moses.

Paul described himself as a servant of the New Covenant. He preached in the power of the Holy Spirit to draw men to C hrist. He preached Christ crucified. Paul did not preach the law to the Gentiles to draw them to Christ. To Paul the law w as old Covenant which had passed away.

The effects of preaching law will have these consequences in 2nd Corinthians 3:15-16,

... But to this day whenever Moses is read, a veil lies over their heart but whenever a person turns to the Lord, the veil is taken away...

Again better to preach Christ than law.

And again the last two verses of 2nd Corinthians 3 should be of great encouragement for those under the New Covenan t,

We are not saved by the law but we are convinced and convicted of our sin by the law. "For by the law is the knowledge of sin" (Romans 3:20).

The law was sent "that every mouth may be stopped, and all the world may become guilty before God" (Romans 3:19). "The law was our schoolmaster to bring us unto Christ, that we might be justified by faith" (Galatians 3:24).

"The law is holy... and just, and good. Was then that which is good made death unto me? God forbid. But sin, that it might appear sin, working death in me by that which is good; that sin by the commandment might become exceedingly sinful" (Romans 7:12-13).

Paul was saying, "I couldn't really confess my sins until I knew they were sins. I couldn't seek after the holiness of God until I saw how far from Him I was. The law hit home to me, destroying my nonchalance about sin. When I saw God's holiness by His commandments, sin became utterly sinful to me."

That is the conviction that drives you straight to the arms of Christ, crying, "Mercy, Lord! I can't save myself, I can't fulfill Your law. I've seen the sin of my heart!"

Faith has been defined as "the flight of a convicted, repentant sinner unto the mercy of God in Christ Jesus." Only the person who has been convicted of his sins by the law of God will "flee to Christ" for refuge.

On the day of Pentecost Peter stood and offered the crowds the gospel of God's grace. But first he put them under the blazing light of the law. He pointed his finger and said, "Ye have taken, and by wicked hands have crucified and slain " (Acts 2:23). The people were pricked in their hearts, so utterly convicted by the Word of God they cried out, "What shall we do?" (verse 37).

Adam was given the gospel of graceÃ,â€'after his "eyes were opened" (see Genesis 3:7). It was only after he had seen hi

The law just sets the contrast to make sin exceedingly sinful. It is more a means of preaching to the Jew. It is also useful to preach to the religious churchgoer who is not yet born again but keep an outward form of righteousness. This was ap plied mostly during the great awakenings. They were in a sense comparable to law-abiding Jews.

The ultimate sin of mankind is not breaking the comandments but unbelieve. Unbelieve leads to breaking the command ments.

John 16:8 And when He has come, He will convict the world of sin, and of righteousness, and of judgment: 9 of sin, because they do not believe in Me; 10 of righteousness, because I go to My Father and you see Me no more; 11 of judgment, because the ruler of this world is judged.

Galatians 3:1-2

You foolish Galatians, who has bewitched you, before whose eyes Jesus Christ was publicly portrayed as crucified? This is the only thing I want to hear from you did you receive the Spirit by the Works of the law, or by hearing with faith.

A very appropriate question to ask since some believe that the work of the law is to kill those that are under it. A very appropriate question to ask since some believe that we have to preach the law before the gospel is preached?

I submit that one will not receive the spirit, let alone the gospel, through the preaching of the law. But rather one must preach the cross of Christ. Paul indicates that Jesus Christ was publicly portrayed as crucified before the Galatians. As such when they heard the gospel through the preaching of the cross they receive also the Spirit of Jesus into their lives.

Romans 10:17 says so faith comes from hearing and hearing by the word of Christ. The word of Christ is that message which Paul first received and then passed on to those who would hear it. He articulates the gospel is the death burial and resurrection of Jesus Christ according to the scriptures. But the cross is a centrality of the Gospel. Here there is no law preaching but the setting forth of Christ and him crucified. For his message was always the crucified Christ that would draw all men to salvation in Him.

In going through the New Testament I see no record where Paul preached the law to gentiles. But it was always the pre aching of the cross of Christ.

Because I pray for the persecuted I watch videos about what God is doing in restricted Nations. Particularly among Mus lims. The videos tell of credible reports where Jesus is appearing to Muslims in dreams and visions. This is resulting in t heir coming to faith in Christ and following Him. In the reports there is no mention of them having to go to Moses and be Killed by the law. And then they come to Christ. The vision of Jesus himself appearing to Muslims is enough to turn their hearts toward faith in Him.

In my own experiences from the Jesus movement it was enough that one hear the gospel and then respond to the Lord Jesus Christ. The Holy Spirit was quite sufficient to work in one's life to convict them of their need for a savior. The Ten Commandments would never preached.

Again I submit the Holy Spirit is quite sufficient to convict one's heart of their need for the Lord Jesus Christ. THE FIRST COVENANT by Andrew Murry

"Now therefore, if ye will obey My voice, and keep My covenant, ye shall be a peculiar treasure unto Me."-Ex. xix. 5.

"He declared unto you His covenant, which He commanded you to perform, even ten commandments. "-DEUT. iv. 13.

"If ye keep these judgments, the Lord thy God shall keep unto thee the covenant, "DEUT. vii. 12.

"I will make a new covenant with the house of Israel, not according to the covenant which I made with their fathers, which My covenant they brake."-JER. xxxi. 31, 32.

WE have seen how the reason for there being two Covenants is to be found in the need of giving the Divine and the hu man will, each their due place in the working out of man's destiny. God ever takes the initiative. Man must then have the opportunity to do his part, and to prove either what he can do, or needs to have done for him. The Old Covenant was on the one hand indispensably necessary to waken man's desires, to call forth his efforts, to deepen the sense of dependen ce on God, to convince of his sin and impotence, and so to prepare him to feel the need of the salvation of Christ. In the significant language of Paul, "The law was our schoolmaster unto Christ." "We were kept under the law, shut up unto the faith, which should afterwards be revealed." To understand the Old Covenant aright we must ever remember its two gre at characteristics ---the one, that it was of Divine appointment, fraught with much true blessing, and absolutely indispens able for the working out of God's purposes; the other, that it was only provisional and preparatory to something higher, a nd therefore absolutely insufficient for giving that full salvation which man needs if his heart or the heart of God is to be s atisfied.

Note now the terms of this first Covenant. "If ye will obey My voice and keep My covenant, ye shall be unto Me a holy na tion." Or, as it is expressed in Jeremiah (vii. 23, xi. 4), "Obey My voice, and I will be your God." Obedience everywhere, especially in the Book of Deuteronomy, appears as the condition of blessing. "A blessing if ye obey" (xi. 27). Some may ask how God could make a covenant of which He knew that man could not keep it. The answer opens up to us the whol e nature and object of the Covenant. All education, Divine or human, ever deals. with its pupils on the principle--faithfuln ess in the less is essential to the attainment of the greater. In taking Israel into His training, God dealt with them as men in whom, with all the ruin sin had brought, there still was a conscience to judge of good and evil, a heart capable of being stirred to long after God, and a will to choose the good and to choose Himself. Before Christ and His salvation could be revealed and understood and truly appreciated, these faculties of man had to be stirred and wakened. The law took men into its training, and sought, if I may use the expression, to make the very best that could be made of them by external in struction. In the provision made in the law for a symbolical atonement and pardon, in all God's revelation of Himself thro ugh priest and prophet and king, in His interposition in providence and grace, everything was done that He could do, to touch and win the heart of His people and to give force to the appeal to their self-interest or their gratitude, their fear or the

eir love.

Its work was not without fruit. Under the law, administered by the grace that ever accompanied it, there was trained up a number of men whose great mark was the fear of God, and a desire to walk blameless in all His commandments. And y et, as a whole, Scripture represents the Old Covenant as a failure. The law had promised life; but it could not give it (De ut. iv. 1; Gal. iii. 21). The real purpose for which God had given it was the very opposite: it was meant by Him as "a mini stration of death." He gave it that it might convince man of his sin, and might so waken the confession of his impotence, and of his need of a New Covenant and a true redemption. It is in this view that Scripture uses such strong expressions—"By the law is the knowledge of sin: that every mouth may be stopped, and the whole world may become guilty before G od." "The law worketh wrath." "The law entered, that the offence might abound." "That sin by the commandment might a ppear exceeding sinful." "As many as are of the works of the law are under the curse." "We were kept under the law, shu t up to the faith, which should afterwards be revealed." "Wherefore the law was our schoolmaster to bring us to Christ, th at we might be justified by faith." The great work of the law was to discover what sin was: its hatefulness as accursed of God; its misery, working temporal and eternal ruin; its power, binding man down in hopeless slavery; and the need of a Divine interposition- as the only hope of deliverance.

In studying the Old Covenant we ought ever to keep in mind the twofold aspect under which we have seen that Scripture represents it. It was God's grace that gave Israel the law, and wrought with the law to make it work out its purpose in individual believers and in the people as a whole. The whole of the Old Covenant was a school of grace, an elementary school, to prepare for the fullness of grace and truth in Christ Jesus. A name is generally given to an object according to its chief feature. And so the Old Covenant is called a ministration of condemnation and death, not because there was no grace in it-it had its Own glory (2 Cor. iii. 10-12)-but because the law with its curse was the predominating element. The combination of the two aspects we find with especial clearness in Paul's epistles. So he speaks of all who are of the works of the law as under the curse (Gal. iii. 10). And then almost immediately after he speaks of the law as being our benefact or, a schoolmaster unto Christ, into whose charge, as to a tutor or governor, we had been given, till the time appointed of the Father. We are everywhere brought back to what we said above. The Old Covenant is absolutely indispensable for the preparation work it had to do; utterly insufficient to work for us a true or a full redemption.

The two great lessons God would teach us by it are very simple. The one is the lesson of SIN, the other the lesson of H OLINESS. The Old Covenant attains its object only as it brings men to a sense of their utter sinfulness and their hopeles s impotence to deliver themselves. As long as they have not learnt this, no offer of the New Covenant life can lay hold of them. As long as an intense longing for deliverance from sinning has not been wrought, they will naturally fall back into t he power of the law and the flesh. The holiness which the New Covenant offers will rather terrify than attract them; the life in the spirit of bondage appears to make more allowance for sin, because obedience is declared to be impossible.

The other is the lesson of Holiness. In the New Covenant the Triune God engages to do all. He undertakes to give and k eep the new heart, to give His own Spirit in it, to give the will and the power to obey and do His will. As the one demand of the first Covenant was the sense of sin, the one great demand of the New is faith that that need, created by the discipl ine of God's law, will be met in a Divine and supernatural way. The law cannot work out its purpose, except as it brings a man to lie guilty and helpless before the holiness of God. There the New finds him, and reveals that same God, in His gr ace accepting him and making him partaker of His holiness.

Because we live in a period known as the age of God's grace, it has become a popular thing to declare that the Ten Commandments are no longer valid, no longer relevant in our society. With that context, it has become apparent that Christ ian churches are not paying attention to the Ten Commandments. But Dwight L Moody preached often in the commandments. John Wesley said he preached the commands of the Law to prepare the way for the gospel. R. A. Torrey told ministers if they did not preach the Law they would have no response to the preaching of the gospel. It is the Law that shows us our need for the gospel of salvation and forgiveness! WHAT THE LAW TEACHES by Watchman Nee

Many Christians are suddenly launched into the experience of Romans 7 and they do not know why. They fancy Romans 6 is quite enough. Having grasped that, they think there can be no more question of failure, and then to their utmost surprise they suddenly find themselves in Romans 7. What is the explanation?

First let us be quite clear that the death with Christ described in Romans 6 is fully adequate to cover all our need. It is the explanation of that death, with all that follows from it, that is incomplete in chapter 6. We are as yet still in ignorance of the truth set forth in chapter 7. Romans 7 is given to us to explain and make real the statement in Romans 6.14, that: "Sin shall not have dominion over you: for ye are not under law, but under grace." The trouble is that we do not yet know deliverance from law. What, then, is the meaning of law?

Grace means that God does something for me; law means that I do something for God. God has certain holy and righteous demands which He places upon me: that is law. Now if law means that God requires something of me for their fulfilment, then deliverance from law means that He no longer requires that from me, but Himself provides it. Law implies that God requires me to do something for Him; deliverance from law implies that He exempts me from doing it, and that in grace He does it Himself. I (where 'I' is the 'carnal' man of ch. 7. 14) need do nothing for God: that is deliverance from law. The trouble in Romans 7 is that man in the flesh tried to do something for God. As soon as you try to please God in that way, then you place yourself under law, and the experience of Romans 7 begins to be yours.

As we seek to understand this, let it be settled at the outset that the fault does not lie with the Law. Paul says, "the law is holy, and the commandment holy, and righteous, and good"

...But if the ministry of death, on letters engraved on stones, came with glory, so that the sons of Israel could not look int ently at the face of Moses because of the glory of his face, fading as it was, how will the ministry of the Spirit fail to be ev en more with glory? If the ministry of condemnation has glory, much more does the ministry of righteousness abound in glory. For indeed what had glory, in this case has no glory because of the glory of that surpasses it...

The above passage is in The New American Standard translation is a little awkward to read. But the bottom line is the gl ory of the old covenant has passed away. We are under a new covenant that has greater glory and remains to this day. In 2 Cor.2:6 Paul comments,

... who has made us as adequate as servants of a new covenant, not of the letter but of the Spirit; for the letter kills but t he spirit gives life...

For Paul to preach the law, he would have been a servant of the old covenant. But he regarded himself as a servant of the new covenant by preaching the gospel in the power of the Holy Spirit. In 1st Corinthians 15:3-4 Paul writes,

...For I delivered to you as of first importance what I also received, that Christ died for our sins according to the Scripture s, and that He was buried, and that He was raised on the third day according to the scriptures...

Paul also writes 1 Corithians 2:1-4,

...And when I came to you, brethren, I did not come with superiority of speech or of wisdom proclaiming to you the testim ony of God. For I determined to know nothing among you accept Jesus Christ, and Him crucified. I was with you in wea kness and in fear and in much trembling. And my message and my preaching were not in persuasive words of wisdom, but in demonstration of the Spirit and of power, so that your faith would not rest on the wisdom of man, but on the power of God..

Dear sister what Paul was doing was preaching Christ crucified as a servant of the New Covenant in the power of the Sp irit. I think the early English Baptists got it right in their first confession in Artcle 25,

... The preaching of the gospel to the conversion of sinners is absolutely free; no way requiring an absolutely necessary, any qualification, preparation, or terrors of the law, or proceeding ministry of the law...

I am not placing confessions of faith on the par of scripture. But even the these early Baptist saw that it was sufficient to preach Christ and Christ alone for the salvation of sinners. Trusting that the Holy Spirit would convict and draw those si nners unto Christ Himself.

There is the old law which is heard by men still in the flesh, and the new law, which is heard and understood by men in the Spirit. It is the same, the will of God (but in OT times spoken figuratively)
