## THE VIRGIN BIRTH

Passing strange, is it not, that with such a clear record anyone can deny that the BIBLE TEACHES THE VIRGIN BIRTH. We can understand how men can reject the Bible record, but how men can say that the Bible does not teach the VIRGIN BIRTH is beyond conception.

The Bible teaches plainly that Jesus was conceived in the womb of a virgin Jewish mother by a supernatural insemination of the Holy Ghost, wholly and apart from any generation by a human father. This the Bible teaches so plainly that to the believer there is no doubt. The record cannot be mistaken by the enlightened and honest student of the Word.

## **JESUS SINLESS**

The Bible teaches in addition that Jesus was a SINLESS man. While all men from Adam to this day are born with Adam 's sinful nature, and, therefore, are subject to the curse and eternal death, the Man Jesus was without sin and, there fore, DEATHLESS until He took the sin of others upon Himself and died THEIR death. Now while Jesus was of Adam's r ace according to the flesh yet He did not inherit Adam's nature. This alone will prove that sin is not transmitted through t he flesh. It is transmitted through the blood and not the flesh, and even though Jesus was of the "Seed of David according to the flesh" this could not make him a sinner.

God has made of ONE BLOOD ALL THE NATIONS of the earth. Sinful heredity is transmitted through the blood and not through the flesh. Even though Jesus, therefore, received His flesh, His body from a sinful race, He could still be sinless

as long as not a drop blood of this sinful race entered His veins. God must find a way whereby Jesus could be perfectly human according to the flesh and yet not have the blood of sinful humanity. That was the problem solved by the virgin bi rth.

#### ORIGIN OF THE BLOOD

It is now definitely known that the blood which flows in an unborn babies arteries and veins is not derived from the mothe r but is produced within the body of the foetus itself only after the introduction of the male sperm. An unfertilized ovum can never develop blood since the female egg does not by itself contain the elements essential for the production of this blood. It is only after the male element has entered the ovum that blood can develop. As a very simple illustration of this, think of the egg of a hen. An unfertilized egg is just an ovum on a much larger scale than the human ovum. You may incubate this unfertilized hens egg but it will never develop. It will decay and become rotten, but no chick will result. Let that egg be fertilized by the introduction of the male sperm and incubation will bring to light the presence of LIFE IN THAT E GG. After a few hours it visibly develops. In a little while red streaks occur in the egg denoting the presence of Blood. This can never occur and does never occur until THE MALE SPERM HAS BEEN UNITED WITH THE FEMALE OVUM. The male element has added life to the egg. Life is in the blood according to scripture, for Moses says:

"For the life of the flesh is in the blood." (Leviticus 17:11). "For it is the life of all flesh; the blood of it is for the life thereof. "â€'Leviticus 17:14

Since there is no life in the egg until the male sperm unites with it, and the life is in the blood, it follows that the male sperm is the source of the blood, the seed of life. Think it through.

#### NO MOTHERS BLOOD

For this very reason, it is unnecessary that a single drop of blood be given to the developing embryo in the womb of the mother. Such is the case according to science. The mother provides the foetus (the unborn developing infant) with the n utritive elements for the building of that little body in the secret of her bosom, but all the blood which forms in that little bo dy is formed in the embryo itself and only as a result of the contribution of the male parent. From the time of conception t o the time of birth of the infant not ONE SINGLE DROP OF BLOOD ever passes from mother to child. The placenta that mass of temporary tissue known better as "afterbirth,†forming the union between mother and child is so construct ed that although all the soluble nutritive elements such as proteins, fats, carbohydrates, salts, minerals and even antibod ies pass freely from mother to child and the waste products of the child's metabolism are passed back to the mothers cir culation, no actual interchange of a single drop of blood ever occurs normally. All the blood which is in that child is produced within the child itself as a result of the introduction of the male sperm. The mother contributes no blood at all.

#### **TESTIMONY OF SCIENCE**

Now for the sake of some of the skeptics who may doubt these statements let me quote from a few reliable authorities. In Howell's Textbook of Physiology, Second Edition, pages 885 and 886, I read:

"For the purpose of understanding its general functions it is sufficient to recall that the placenta consists essentially of va scular chorionic papillae from the foetus (the unborn child) bathed in the large blood spaces of the decidual membrane of the mother. The fetal and maternal blood DO NOT COME INTO ACTUAL CONTACT. THEY ARE SEPARATED FRO M EACH OTHER by the walls of the fetal blood vessels and the epithelial layers of the chorionic villae."

Or let me quote from Williams' Practice of Obstetrics, Third Edition, page 133. Here I quote,

"The fetal blood in the vessels of the chorionic villae AT NO TIME GAINS ACCESS TO THE MATERNAL BLOOD in the intervillous space, BEING SEPARATED FROM ONE ANOTHER by the double layer of chorionic epithelium."

And from page 136 of the same recognized textbook I quote,

"Normally there is no communication between the fetal blood and the maternal blood."

Now for the benefit of those of you who may be nurses, let me quote from a textbook which is familiar to you. Quoting from "Nurse's Handbook of Obstetrics" by Louise Zabriskie, R.N., Fifth Edition, page 75:

"When the circulation of the blood begins in the embryo, it remains separate and distinct from that of the mother. All food and waste material which are interchanged between the embryo and the mother must pass through the blood vessel wal Is from one circulation to the other."

And from page 82 of the same book:

"The foetus receives its nourishment and oxygen from the mothers blood into its own through the medium of the placent a. The fetal heart pumps blood through the arteries of the umbilical cord into the placental vessels, which, looping in and out of the uterine tissue and lying in close contact with the uterine vessels, permit a diffusion, through their walls, of wast e products from child to mother and of nourishment and oxygen from mother to child. As has been said, this interchange is effected by the process of osmosis, and there is no direct mingling of the two blood currents. In other words, no mater nal blood actually flows to the foetus, nor is there any direct fetal blood flow to the mother."

GOD'S WONDERFUL PROVISION

How wonderfully God prepared for the virgin birth of His Son. When He created woman He made her so that no blood w

ould be able to pass from her to her offspring. That blood is the result of the male. Since Adam was the federal head of t he race, it is HIS BLOOD which transmits Adam's Sin. In order to produce a sinless man and yet be the son of Adam, G od must provide a way whereby that man would have a human body derived from Adam but have not a drop of Adam's s inful blood. Right here is the scientific biological reason for the sinlessness of the Man Christ Jesus. Some have tried to answer the question, "How could He be sinless and yet born of a woman?†by making Mary the "Immaculate V irgin.†That, however, does not answer the question of how JESUS was sinless since it is through the male that the bl oodline runs.

Not only is this a scientific fact, but it is plainly taught in Scripture that Jesus partook of human flesh without Adam's bloo d. In Hebrews 2:14 we read,

"Forasmuch then as the children are partakers of flesh and blood. He also himself likewise took part of the same..."

You will notice that the children, that is the human children, are said to be partakers of FLESH and BLOOD, and then speaking of Jesus it says that He "himself likewise took part of the same." The Word "took part†as applying to Chr ist is an entirely different word then "partakers†as applied to the children. In the margin of my Bible, I read the word translated "took part†implies "taking part in something outside one's self.†The Greek word for partak ers is "KOYNONEHO" and means "to share fully,†so that all of Adam's children share fully in Adam's fles h and blood. When we read that Jesus "took part of the same†the word is "METECHO" which means to take "part " but not all. The Children take both flesh and blood of Adam but Christ took only part, that is the flesh part, while the blo od was the result of supernatural conception.

Jesus was a perfect human being after the flesh. He was of the seed of David according to the flesh, but blood is that pa rt of a man which is the divine addition. In the creation of man, Adam's body was made from the dust of the earth, b ut God breathed into his nostrils the breath of life. Since life is in the blood, this act resulted in the formation of blood in A dam's body, but the first Adam's blood was corrupted and sin transmitted through it to all mankind. In the last A dam and the second man, new and divine and sinless blood was produced in a body that was the seed of Adam and by this resulted in the production of â€"

#### **DIVINE BLOOD**

Conception by the Holy Ghost then was the only way the Virgin Birth could be accomplished. Mary contributed the body of Jesus and He became the "seed of David according to the flesh." The Holy Spirit contributed the Blood of Jesus. It was sinless blood. It was Divine blood. It is Precious Blood for there has never been any other like it. It is â€'

Yes, the blood our Saviour shed points to Who He is; therefore the use of that term "the blood of Christ," "His blood," etc., always calls our attention to Who it is that died for us on that Cross.

Four times it says in the Bible that it was His "own" blood - Acts 20:28; Heb. 9:12; Heb. 13:12 and Rev. 1:5. We don't say when someone for instance gives a pint of blood to another that he gave his "own" blood; we just say his blood. But G od wants us to know that this blood He shed is special; it is whose blood it is that is of vital importance. It is the only blood ever called "precious" (or priceless) blood. And again I say, it is that because it is the blood of the Son of God. The prie st of old gave the blood of others (animals) for his own sins--Heb. 7:27, but our blessed Lord gave His own blood for the sins of others. Praise His Holy Name!

When man dies that is the last thing he does, but when our blessed Lord shed His blood it is the first thing He did for us. That's why it says in I John 5:6 that He "came" by blood. We say when a man dies that he went, but when our Lord shed His blood on the Cross, it says He came. Praise God, His precious death His precious blood -ushers in an eternity of blis s for the believer in Him.

In the Old Testament the blood was never put on the sinner; it was put on the believer. It was put on the priests -Ex. 29: 20, and we know they represent the believers of this day, for we are the holy priesthood. The blood of Jesus is the greatest mystery of eternity, the deepest mystery of the divine wisdom. Let us not imagine that we can easily grasp its meaning. God thought 4,000 years necessary to prepare men for it, and we also must take time, if we are to gain a knowledge of the power of the blood.

Even taking time is of no avail, unless there is definite taking of sacrificial trouble. Sacrificial blood always meant the offe ring of a life. The Israelite could not obtain blood for the pardon of his sin, unless the life of something that belonged to him was offered in sacrifice. The Lord Jesus did not offer up His own life, and shed His blood to .spare us from the sacrifice of our lives. No, indeed 1 but to make the sacrifice of our lives possible and desirable.

The hidden value of His blood is the spirit of self-sacrifice, and where the blood really touches the heart, it works out in t

hat heart, a like spirit of self-sacrifice. We learn to give up ourselves and our lives, so as to press into the full power of th at new life, which the blood. has provided.

We give our time in order that we may become acquainted with these things by God's Word. We separate ourselves fro m sin and worldly-mindedness, and self-will, that the power of the blood may not be hindered, for it is just these things th at the blood seeks to remove.

We surrender ourselves wholly to God in prayer and faith, so as not to think our own thoughts, and not to hold our own lives as a prize, but as possessing nothing save what He bestows. Then He reveals to us the glorious and blessed life which has been prepared for us by the blood.

iv. We can rely upon the Lord Jesus to reveal to us the power of His blood.

It is by this confident trust in Him that the blessing obtained by the blood becomes ours. We must never, in thought, sep arate the blood from the High Priest who shed it, and ever lives to apply it.

He who once gave His blood for us, will, oh I so surely, every moment, impart its efficacy. Trust Him to do this. Trust Him to open your eyes, and to give you a deeper spiritual insight. Trust Him to teach you to think about the blood as God thin ks about it. Trust Him to impart to you, and to make effective in you, all that He enables you to see.

Trust Him above all, in the power of His eternal High Priesthood, to work out in you, unceasingly, the full merits of His blood, so that your whole life may be an uninterrupted abiding in the sanctuary of God's presence.

Believer, you who have come to the knowledge of the precious blood, hearken to the invitation of your Lord. Come near er. Let Him teach you; let Him bless you. Let Him cause His blood to become to you spirit, and life, and power, and truth. Begin now, at once, to open your soul in faith, to receive the full, mighty, heavenly effects of the precious blood, in a mor e glorious manner than you have ever experienced. He Himself will work these things out in your life.

Its effects are manifold, for we read in Scripture of RECONCILIATION through the blood; CLEANSING through the blood d; SANCTIFICATION through the blood; UNION WITH GOD through the blood; VICTORY over Satan through the blood; LIFE through the blood.

These are separate blessings but are all included in one sentence: REDEMPTION BY THE BLOOD.

It is only when the believer understands what these blessings are, and by what means they may become his, that he can experience the full power of REDEMPTION.

Before passing on to consider in detail these several blessings let us first inquire, in a more general way, concerning TH E POWER OF THE BLOOD OF JESUS.

1st. WHEREIN DOES THE POWER OF THAT BLOOD LIE?

What a glorious thought for everyone who desires to experience the full power of the blood

ii. But the power of the blood lies above everything else in the fact that it is offered to God on the altar for redemption.

When we think of blood as shed, we think of death; death follows, when the blood or the soul is poured out. Death make s us think of sin, for death is the punishment of sin. God gave Israel the blood on the altar, as the atonement or covering for sin; that means-the sins of the transgressor were laid on the victim, and its death was reckoned as the death or punis hment for the sins laid upon it.

The blood was thus the life given up to death for the satisfaction of the law of God, and in obedience to His command. Sin was so entirely covered and atoned for, it was no longer reckoned as that of the transgressor. He was forgiven.

But all these sacrifices and offerings were only types, and shadows, till the Lord Jesus came. His blood was the reality to which these types pointed.

His blood was in itself of infinite value, because it carried His soul or life. But the atoning virtue of His blood was infinite a lso, because of the manner in which it was shed. In holy obedience to the Father's will He subjected Himself to the penal ty of the broken law, by pouring out His soul unto death. By that death, not only was the penalty borne, but the law was s atisfied, and the Father glorified. His blood atoned for sin, and thus made it powerless. It has a marvellous power for rem oving sin, and opening heaven for the sinner; whom it cleanses, and sanctifies, and makes meet for heaven.

It is because of the Wonderful Person whose blood was shed; and because of the wonderful way in which it was shed, fulfilling the law of God, while satisfying its just demands, that the blood of Jesus has such wonderful power. It is the blood of Atonement, and hence has such efficacy to redeem; accomplishing everything for, and in, the sinner, that is necess ary to salvation.

The Blood Does NOT Merely Represent Jesus' Death!

There is a damnable heresy circulating in many of our churches today, popularized by religious liberal, John MacArthur. Moody Publishers sadly prints all of MacArthur's liberal books these days. It is a sinful thing to diminish the literal teachings of the Bible as only being figurative unless the Bible indicates otherwise. For example: In Revelation 1:20 we are told that the mystery of the seven stars are the seven angels, and the seven candlesticks are the seven churches. No where in the Bible are we ever told that the de ath of Jesus is represented by the blood. Thus, if the Bible teaches in Hebrews 9:12 that Jesus entered into the heavenl y holy place BY HIS OWN BLOOD, then we must accept this truth literally. MacArthur is perverting the Scriptures. When God told Moses to warn the Israelites concerning the coming 10th plague, i.e., the death of the firstborn, the peopl e were instructed to kill a lamb, and then APPLY the lamb's blood to the side and upper doorposts of the home. John Ma cArthur likely learned his heresies from Robert B. We have seen that SANCTIFICATION is more than separation. That is only the beginning. We have seen also that personal consecration and hearty willing surrender to live only for, and in God's holy will, is part of SANCTIFICATION.

In what way can the blood of Christ work out this surrender in us, and SANCTIFY us in that surrender? The answer is no t difficult. It is not enough to believe fully in the power of the blood to redeem us, and to free us from sin, but we must, ab ove all, notice the source of this power.

We know that it has this power, because of the willingness with which the Lord Jesus surrenders Himself. In the sheddin g of His blood He sanctifies: Himself, offered Himself entirely to God and His holiness. It is because of this that the blood is so holy, and possesses such sanctifying power. In the blood we have an impressive representation of the self-surrend er of Christ. The blood ever speaks of the consecration of Jesus to the Father, as the opening of the way, and supplying the power for victory over sin. And the closer we come into contact with the blood, and the more we live under the deep i mpression of having been sprinkled by the blood, we shall hear more clearly the voice of the blood, declare that "Entire's urrender to God is the way to full redemption from sin."

The voice of the blood will not speak simply to teach us or to awaken thought; the blood speaks with a divine and life giving power. What it commands, that it bestows. It works out in us the same disposition that was in our Lord Jesus. By His own blood Jesus sanctifies Himself then us, that we, holding nothing back, might surrender ourselves with all our hearts to the holy will of God.

But CONSECRATION itself even along with any; following SEPARATION is still only a preparation, Entire Sanctification takes place when God takes possession of and fills with His glory the temple that is consecrated to Him. "There will I me et with the children of Israel, and they shall be sanctified by my glory" (Exod. xxix. 43j. Actual, complete SANCTIFICATI ON consists in God's impartation of His own holiness-of Himself.

Here also the blood speaks:-It tells us that heaven is opened, that the powers of the heavenly life have come down to earth, that every hindrance has been removed, and God can make His abode with man.

Immediate nearness and fellowship with God, are made possible by the blood. The believer who surrenders himself unreservedly to the blood, obtains the full assurance that God will bestow Himself wholly, and will reveal His holiness in him

How glorious are the results of such a SANCTIFICATION! Through the Holy Spirit, the soul's intercourse is in the living e xperience of God's abiding nearness; accompanied by the awakening of the tenderest carefulness against sin; guarded by caution and the fear of God.

But to live in watchfulness against sin does not satisfy the soul. The temple must not only be cleansed but it must be fille d with God's glory. All the virtues of divine holiness, as manifested in the Lord Jesus, are to be sought for and found, in f ellowship with God. Sanctification means union with God in the eternal life and power of the Blood of Christ; fellowship in His will; sharing His life; conformity to His image.

"""But Christ Himself cannot make us partakers of eternal life which He has procured for us, save by the shedding of His blood, and causing us to drink it. Marvellous fact! " NOT WITHOUT BLOOD " can eternal life be ours.

Equally striking is our Lord's declaration of the same truth on the last night of His earthly life. Before He completed the gr eat work of His life by giving it " as a ransom for many," He instituted the Holy Supper, saying-" This cup is the New Test ament in MY BLOOD that is shed for you and for many for the remission of sins. Drink ye all of it." (Matt. xxvi. 28). "without shedding of blood there is no remission of sins." Without remission of sins there is no life. But by the shedding of His BLOOD He has obtained a new life for us. By what He calls " the drinking of His blood " He shares His life with us. The blood SHED in the Atonement, which frees us from the SIN, the guilt of sin; and from death, the punishment of sin; the blo od, which by faith we drink, bestows on us His life. The BLOOD He shed was, in the first place FOR us, and is then give

n TO us.

### III. THE TEACHING OF THE APOSTLES UNDER THE INSPIRATION OF THE HOLY SPIRIT.

After His Resurrection and Ascension, our Lord is not any longer known by the Apostles "after the flesh." Now, all that w as symbolical has passed away, and the deep spiritual truths expressed by symbol, are unveiled.

But there is no veiling of THE BLOOD. It still occupies a prominent place.

Turn first to the Epistle to the Hebrews, which was written purposely to show that the Temple service had become unpro fitable, and was intended by God to pass away, now that Christ had come.

Here, if anywhere, it might be expected that the Holy Spirit would emphasise the true spirituality of God's purpose, yet it is just here that the Blood of Jesus is spoken of in a manner that imparts a new value to the phrase.

We read concerning our Lord that "by His own blood he entered into the holy place" (Heb. ix. 12).

"The Blood of Christ-shall purge your conscience" (ver. 14).

"Having therefore, brethren, boldness to enter into the holiest by the blood of Jesus" (Heb. x. 19).

"Ye are come-to Jesus the Mediator of the New Covenant, and to the blood of sprinkling" (xii. 24).

"Jesus also, that he might sanctify the people with his own blood suffered without the gate" (xiii. 12, 23).

"God-brought again from the dead our Lord Jesus-through the blood of the everlasting covenant" (xiii. 20).

By such words the Holy Spirit teaches us that the blood is really the central power of our entire redemption. "NOT WITH OUT BLOOD" is as valid in the New Testament as in the Old.

Nothing but the Blood of Jesus, shed in His death for sin, can cover sin on God's side, or remove it on ours.

We find the same teaching in the writings of the Apostles. Paul writes of "being justified freely by his grace through the r edemption that is in Christ Jesus . . . through faith in his blood" (Rom. iii. 24, 25), Of "being now justified by his blood" (v. 9).

To the Corinthians he declares that the "cup of blessing which we bless is the communion of the Blood of Christ" (I Cor. x. I6).

In the Epistle to the Galatians he uses the word "CROSS" to convey the same meaning, while in Colossians he united the two words and speaks of "The Blood of his Cross" (Gal. vi. 14; Col. i. 20).

He reminds the Ephesians that "We have redemption through his blood" and that we "are made nigh by the blood of Chri st" (Eph. i. 7 and ii. I3).

Peter reminds his readers that they were "Elect . . . unto obedience and sprinkling of the Blood of Jesus" (I Pet. i. 2), that they were redeemed by "the precious blood of Christ" (ver. 19).

See how John assures his "little children" that "The blood of Jesus Christ his Son cleanseth us from all sin" (I John i. 7). The Son is He "who came not by water only but by water and blood" (v. 6).

All of them agree together in mentioning the blood, and in glorying in it, as the power by which eternal redemption through Christ, is fully accomplished, and is then applied by the Holy Spirit.

IV. But perhaps this is merely earthly language. What has Heaven to say? WHAT DO we LEARN FROM THE BOOK OF REVELATION CONCERNING THE FUTURE GLORY AND THE BLOOD?

It is of the greatest importance to notice, that in the revelation which God has given in this book, of the glory of His thron e, and the blessedness of those who surround it, the blood still retains its remarkably prominent place.

On the throne John saw "A Lamb as it had been slain" (Rev. v. 6). As the Elders fell down before the Lamb they sang a new song saying, "Thou art worthy . . . for thou vast slain and hast redeemed us to God by thy blood" (vers. 8 and 9).

Later on when he saw the great company which no man could number, he was told in reply to his question as to who the y were, "They have washed their robes, and made them white in the blood of the Lamb."

Then again, when he heard the song of victory over the defeat of Satan, its strain was, "They overcame him by the blood of the Lamb" (xii. 11).

In the glory of heaven, as seen by John, there was no phrase by which the great purposes of God; the wondrous love of the Son of God; the power of His redemption; and the joy and thanksgiving of the redeemed; can be gathered up and ex pressed save this-"THE BLOOD OF THE LAMB." From the beginning to the end of Scripture; from the closing of the gat es of Eden, to the opening of the gates of the Heavenly Zion, there runs through Scripture a golden thread. It is "THE BLOOD" that unites the beginning and the end; that gloriously restores what sin had destroyed.

It is not difficult to see what lessons the Lord wishes us to learn from the fact that the blood occupies such a prominent p lace in Scripture.

i. God has no other way of dealing with sin, or the sinner,

save through the blood.

For victory over sin and the deliverance of the sinner God has no other means or thought than "THE BLOOD OF CHRIS T." Yes, it is indeed something that surpasses all understanding.""

The Value and Use of Blood! James Smith, 1865

"Not without blood!" Hebrews 9:7

Blood! There is something startling in the sound of blood, and often more startling in the sight of it. Yet every part of the Bible is sprinkled with blood; and from the sin of Adam  $\hat{a} \in \mathbb{C}$  to the death of Jesus, God required blood. The blood is the life. When God gave man a being, he required that his life should be spent in his service, to his praise. When man failed to obey, his existence was forfeited  $\hat{a} \in \mathbb{C}$  and blood was required. The Son of God, in the everlasting covenant, had engaged to shed His blood for us; in consequence of which, animal blood was demanded in sacrifice  $\hat{a} \in \mathbb{C}$  until His blood should be shed. Abel sacrificed and offered blood  $\hat{a} \in \mathbb{C}$  so did all the patriarchs. Thus they confessed guilt, acknowledged their desert, agreed to substitution, and exercised faith in a coming Savior.

Under the law, everything was sanctified with blood; priests and people, tabernacle and furniture, the book of the covena nt, and even the mercy-seat. Blood was constantly kept before the eyes of the people; and in reference to access to Go d, acceptance with God, or obtaining blessings from God â€" the law said, "Not without blood."

When the blood of Jesus was shed â€' no more blood was required: God was satisfied. But all our privileges, blessings, and enjoyments â€' now come to us through blood â€' the precious blood of Jesus. Are we redeemed? It is through the precious blood of Christ, as of a lamb without blemish and without spot. Are we justified? It is by His blood. Have we pea ce? It is through His blood. Let us look at a few particulars, and see the value and use of the blood.

There is no atonement without blood, for "it is the blood which makes atonement for the soul." The blood of Jesus alone could atone for sin. That met the Divine requirements, that honored the Divine government, that laid a foundation on whi ch God and man could meet and be friends. We are reconciled to God â€' by the death of His Son. We have peace with God â€' by "faith in His blood." The blood of Jesus made a full, perfect, and everlasting atonement for all sin; that whoev er believes may not perish â€' but have everlasting life.

There is no pardon without blood. We have redemption through His blood, even the forgiveness of our sins; but, without shedding of blood, there is no remission of sin. God's justice must be satisfied before His grace can be exercised toward sinners; and thus God is just, while He is the justifier of him who believes in Jesus. Through the blood, anyone may obtain pardon, for nothing is easier, nothing is more pleasant to God, than to pardon sinners for the sake of Jesus; hence it is written, "If we confess our sins, He is faithful and just to forgive us our sins, and to cleanse us from all unrighteousness." But while God pardons every sinner who applies for pardon through the blood of Jesus â€" he will not pardon in any other way; for no blood â€" no pardon; no pleading the blood â€" no enjoyment of pardon.

There is no reconciliation to God without blood. Jesus has made peace through the blood of His cross; and it is at the cross, and at the cross alone â€' that God will meet sinners, and receive them into His favor and friendship. God was in C hrist, reconciling the world unto Himself; and it is through the blood of Jesus â€' that He manifests His pity, compassion, and infinite love now; and it is the manifestation of His pity, compassion, and love â€' which breaks our hearts, produces evangelical repentance, fills us with holy love, and so reconciles us to God's character, perfections, and government. There is no access to God without blood. The way to the mercy-seat was sprinkled with blood, and the blood in the basi n was carried in the hand of the priest when he went into the holiest; so that the first thing that the eye of God saw, was t he blood, and on account of that, he accepted both priest and people. It is through Jesus â€' Jesus as the slain Lamb â€' that we, both Jews and Gentiles, have access by one Spirit unto the Father. The new and living way into the holiest is c onsecrated for us by the blood of our great High Priest, and we have now access with confidence by the faith of Him. There is no subduing sin without blood. Unpardoned sin is unconquered sin; for we can never subdue sin, unless it is brought into contact with the blood of Christ. If the weeds of sin fade and die â€' it is because the blood of Jesus is laid at the roots. The more we exercise faith in the blood of Jesus â€' the more power we gain over our corruptions, and the more easily we overcome our evil propensities.

There is no cleansing from sin without blood. Guilt will adhere to the conscience, torment the spirit, confuse the judgmen t, and produce a thousand horrid fears  $\hat{a} \in \mathbb{C}$  until the blood of Jesus is sprinkled upon it. But if we walk in the light, as our God is in the light, we have fellowship one with another, and the blood of Jesus Christ His Son cleanses us from all sin. All sin  $\hat{a} \in \mathbb{C}$  every sin  $\hat{a} \in \mathbb{C}$  every stain  $\hat{a} \in \mathbb{C}$  every trace of sin! Thus the blood of Christ purges our consciences from dead w orks, to serve the living and the true God. Precious, precious blood of Jesus!

There is no conquering Satan without blood. He cares not for our reasonings. He laughs at many of our feeble attempts to conquer him. But the blood of Jesus makes him tremble and flee before us. Hence it is written of the tempted and persecuted saints of old, that though the old serpent the Devil deceived the whole world â€" "they overcame him by the blood of the Lamb, and the word of their testimony, for they loved not their lives unto the death." Satan will surely flee before us, if we resist him steadfast in the faith; steadfastly believing in the infinite virtue and everlasting efficacy of the blood of Jesus.

There is no walking with God without blood. No criminal can be permitted to enjoy the friendship and fellowship of the So vereign; and such are we, until the blood is apprehended by us, and applied to us. If I would come to God, enjoy peace with God, realize acceptance before God, and hold close and intimate communion with God â€' it must be through the bl ood of His dear Son! I must therefore daily use the blood, washing my robes and making them white in the blood of the L amb.

There is no peace in death without blood. Death dissipates a thousand vain imaginations, destroys a thousand false refu ges, and strips off a thousand false coverings. Many have found that what did for health and ease â€' will not do for sick ness and death. Nothing but the blood of Christ, at the root of our profession, as the ground of our hope, as our plea at t he throne of grace â€' will give us peace in the hour of death. But if we see the worth and excellency of the blood of Jes us, if we rely on it alone for our acceptance with God, if we oppose it to our sins, doubts, and fears â€' there will be peac e; solid, settled, substantial peace. There is no admission to heaven â€' without blood!

Our title-deeds must be signed with blood, or our claim to the heavenly mansions will not be admitted. We go to heaven â€' because Jesus left it, came to earth, and died to entitle us to it; and if we attempt to go on any other grounds, we sha II be rejected and eternally expelled. No blood â€' no heaven. The priest dared not enter the holiest of all, which typified heaven, without blood; nor shall we be allowed to pass over the threshold of the celestial city â€' without the blood of Je sus on us.

Finally, no boldness at the judgment, without blood. This alone will blot out our sins, justify our persons, meet all the dem ands made upon us, and silence every accuser who rises up against us. Only the blood of Jesus will do all this! For ten t housand worlds, I would not meet God in judgment â€' without the blood of Jesus. But if His blood . . .

satisfies justice,

magnifies the law,

harmonizes the Divine attributes,

blots out all my sins,

justifies my person,

cleanses my garments,

silences all my accusers, and

brings the greatest possible glory to God by my salvation

â€" why should I fear the judgment? Shall I not boldly face it, and with everlasting joy rejoice in my acquittal at it? Precio us blood of Jesus! I will seek grace to have more to do with You, to exercise more confidence in You, and to speak more of You than ever I have done!

There must be blood on the altar â€" where we place our sacrifices.

There must be blood on that mercy-seat â€' where we offer our prayers.

There must be blood on the conscience â€" when it passes its verdict.

our sacrifices will not be accepted,

our prayers will not be heard, and

our consciences will condemn us.

In reference therefore to every duty I perform, every privilege I enjoy, every prospect I anticipate â€' I will say, "Not without blood!"

When we speak of the blood of Christ, we refer to His offering the sacrifice of Himself to satisfy divine justice on our beh alf. Personally innocent, He would take the sinner's place, answer for the sins of His people, and be counted as guilty be fore God's justice. It is more that the literal piercing of His side by the Roman soldier. They did indeed pierce His side an d blood and water flowed out, as was foretold in Scripture. The shedding of blood indicates the taking of a life. This is sh own early in the Scriptures where God said to Cain concerning his murdered brother, 'the voice of thy brother's blood cri eth unto me from the ground'. Concerning the Levitical sacrifices the Lord said, 'The life of the flesh is in the blood, and I have given it to you upon the altar to make an atonement for your souls: for it is the blood that maketh an atonement for the soul'. When the paschal lamb was slain the blood had to be shed and sprinkled. Those offerings never made 'the co mers thereunto perfect'; they had no saving efficacy in them. However, they foreshadowed the only blood that could brin g salvation.
