In the context of the whole chapter of Acts 21 we see that the prophet Agabus prophsies saying that Paul would be delivered over to the gentiles, but the people still desired him not to go.

But Paul was determined to not only suffer affliction but die for the name of Christ. It reminds me of this verse:

Hebrews 11:35 - Women recieved their dead raised to life again: and others were tortured, not accepting deliverance; th at they might obtain a better resurrection:

Imagine that! "not accepting deliverance" How real is eternal realities to our life that we see it more clearly and as a bett er thing then all the pleasures and sights of this life.

Wesley again: Act 21:4 - And finding disciples, we tarried there seven days - In order to spend a Sabbath with them. Wh o told Paul by the Spirit - That afflictions awaited him at Jerusalem. This was properly what they said by the Spirit. They t hemselves advised him not to go up. The disciples seemed to understand their prophetic impulse to be an intimation from the Spirit, that Paul, if he were so minded, might avoid the danger, by not going to Jerusalem.

How about Matthew Henry?

3. The disciples at Tyre were endowed with such gifts that they could by the Spirit foretel the troubles Paul would meet w ith at Jerusalem; for the Holy Ghost witnessed it in every city, Act_20:23. Being a thing that would be so much talked of when it came to pass, God saw fit to have it much prophesied of before, that people's faith, instead of being offended, mi ght be confirmed. And withal they were endowed with such graces that foreseeing his troubles, out of love to him and co ncern for the church, especially the churches of the Gentiles, that could ill spare him, they begged of him that he would not go up to Jerusalem, for they hoped the decree was conditional: If he go up, he will come into trouble there; as the pre diction to David that the men of Keilah will deliver him up (that is, if he venture himself with them); and therefore they sai d to him, by the Spirit, that he should not go up, because they concluded it would be most for the glory of God that he should continue at liberty; and it was not at all their fault to think so, and consequently to dissuade him; but it was their mist ake, for his trial would be for the glory of God and the furtherance of the gospel, and he knew it; and the importunity that was used with him, to dissuade him from it, renders his pious and truly heroic resolution the more illustrious.

Through the Spirit - There is some difficulty in understanding this. In solving this difficulty, we may remark:

- (1) That it is evident that the Holy Spirit is meant, and that Luke means to say that this was spoken by his inspiration. The Holy Spirit was bestowed on Christians at that time in large measures, and many appear to have been under his inspiring guidance.
- (2) it was not understood by Paul as a positive command that he should not go up to Jerusalem; for had it been, it would not have been disobeyed. He evidently understood it as expressive of their earnest wish that he should not go, as apprising him of danger, and as a kind expression in regard to his own welfare and safety. Compare Act_21:13. Paul was in be tter circumstances to understand this than we are, and his interpretation was doubtless correct.
- (3) it is to be understood, therefore, simply as an inspired prophetic warning, that if he went, he went at the risk of his life a prophetic warning, joined with their individual personal wishes that he would not expose himself to this danger. The me aning evidently is that they said by inspiration of the Spirit that he should not go unless he was willing to encounter dang er, for they foresaw that the journey would be attended with the hazard of his life. Grotius renders it, Å"That he should not go unless he was willing to be bound.Å" Michaelis and Stolzius; Å"They gave him prophetic warrant that he should not go to Jerusalem.Å" Doddridge, Å"If he tendered his own liberty and safety, not to go up to Jerusalem, since it would cert ainly expose him to very great hazard.Å" The inspiration in the case was that of admonition and warning, not of positive command. Paul was simply apprised of the danger, and was then left to the free determination of his own will. He chose to encounter the danger of which he was thus apprised. He did not despise the intimations of the Spirit, but he judged th at his duty to God called him thus to meet the perils of the journey. We may be apprised of danger in a certain course, ei ther by our friends or by the Word of God, and still it may be our duty to meet it. Our duty is not to be measured by the fact that we shall experience danger, in whatever way that may be made known to us. Duty consists in following the will of God, and encountering whatever trials may be in our way.
