In our culture, the connotation of "leaving" your wife or kids is such that you are doing so in a relationship-ending manne r. I think what Christ is suggesting here is not that a person is leaving in divorce, or breaking the bond of the relationship, or leaving without consent of the wife, but is speaking moreso of how a soldier leaves behind everything to goto war. Wh en a soldier goes off to war, he may leave behind a wife, but his wife graciously bids goodbye fully realizing the sacrifice they both are making.

Obviously, Jesus should always be first in our life. And undoubtedly, God honors the vow we make on our marriage day, uniting two into one. If there is one thing I have learned in my marriage is that God would never unite two people only to divide them later. This means that if my wife and I are in disagreement, God is not there. Anytime there is a disagreement, I quickly seek verification from the Lord. It could be that I am the one who is mistaken.

Obviously, if the Lord is going to call a person away from his or her spouse, he will prepare both. He will put a desire in the heart of the person to go, and a desire in the heart of other to let go. It is awesome that a man would leave his wife t o serve the Lord if the Lord should ask. However, it is even more awesome that a wife should make the sacrifice of givin g her husband to the Lord and supporting him in going. This is a mutual act of love on both the part of the husband and wife.

A man should not leave his wife if it is done with any selfish motive. He should especially not divorce her. And truly, if an y man loved his wife sincerely, he would always consider her needs. He would not take off unless she was well cared for .

Lastly, you asked "is alright for me." I think it's interesting you used these words whether intentional or not. It is almost a s to say, "Can I?"

Think about the heart motives behind such a question. "Is it alright for me"....it almost seems like there is a desire to leave e. If a man truly loved his wife, would he ever desire to leave her?

I don't think the Lord would ever ask a man to leave his wife that wanted to leave his wife. The Lord, when asking a man to leave his wife, is asking for a sacrifice.
