WE HAD FRIENDS and we went outside and found them!

We fell out of trees, got cut, broke bones and teeth and there were no lawsuits from these accidents.

We ate worms and mud pies made from dirt, and the worms did not live in us forever.

We were given BB guns for our 10th birthdays, made up games with sticks and tennis balls and, although we were told it would happen, we did not put out very many eyes.

We rode bikes or walked to a friend's house and knocked on the door or rang the bell, or just walked in and talked to the m!

Little League had tryouts and not everyone made the team. Those who didn't had to learn to deal with disappointment. I magine that!!

The idea of a parent bailing us out if we broke the law was unheard of. They actually sided with the law!

As some one else pointed out it shouldn't be used to foster rebellion a gainst authority, just to be informed that our children can pray and read thier bibles and even have clubs. It is just that the school can't institue these things. Here is the post:

prayer in school

U.S. Supreme CourtENGEL v. VITALE, 370 U.S. 421 (1962)370 U.S. 421 ENGEL ET AL. v. VITALE ET AL. CERTIORARI TO THE COURT OF APPEALS OF NEW YORK.

No. 468.

Argued April 3, 1962.

Decided June 25, 1962.

Because of the prohibition of the First Amendment against the enactment of any law "respecting an establishment of religion," which is made applicable to the States by the Fourteenth Amendment, state officials may not compose an official state prayer and require that it be recited in the public schools of the State at the beginning of each school day - even if the prayer is denominationally neutral and pupils who wish to do so may remain silent or be excused from the room while the prayer is being recited. Pp. 422-436.

Meet Nathan: an average, middle school student who lives in a small mid-western town with his parents and two sisters. One night, at the dinner table, his dad starts a discussion about the importance of prayer. During which, he tells Nathan t hat he needs to be thankful and pray for everything, even when you go through your day at school. ThatÂ's when Nathan said, Â'But dad, we canÂ't pray in school; everybody knows that.Â' And his sister agreed, Â'yeah dad, weÂ're not aloud to pray in school.Â"

Unfortunately there are many students across the country who are just like Nathan, they really believe that, somehow, it Â's against the law to pray in school. ItÂ's not suprising if you listen to what many voices, from both sides of the debate, are saying about prayer in school.

All too common phrases like, "TheyÂ've taken prayer out of the public school." Or, "God has been removed from the class room," Have left many mis-informed and has led to a distorted view of the facts concerning prayer in the public sc hool.

### The Beginning

In 1962 In the Case Engel v. Vitale, the Supreme Court passed a law which states, "The act of leading students in pray er was ruled unconstitutional, even if the prayer was denominationally neutral and pupils who wish to do so may remain silent or be excused from the room while the prayer is being recited" (Supreme Court Case Engel v. Vitale, p 422-436 Miller, para. 4)

This case came about when a school district in New Hyde Park, New York directed the School District's principal to caus e the following prayer to be said aloud by each class in the presence of a teacher at the beginning of each school day: " Almighty God, we acknowledge our dependence upon Thee, and we beg Thy blessings upon us, our parents, our teach ers and our Country."

The State of New York authorized a short, voluntary prayer for recitation at the start of each school day. The question th at was presented in court was: Does the reading of a nondenominational prayer at the start of the school day violate the "establishment of religion" clause of the First Amendment? The answer the court reached was, Yes. The court decided t hat by providing the prayer, New York officially approved religion. Thus prayers led by, and sanctioned by, school official s was prohibited.

Fortunately, the First Amendment to the U.S. Constitution protects both believers and nonbelievers by mandating govern ment neutrality between belief and nonbelief. The government-- through its proxy, the educators and administrators who facilitate our schools, may not lead children in prayer or force them to pray a certain way. However, all children have the right to pray voluntarily before, during, or after school, and non-religious children do not have to pray at all.

During free time at school, whether itÂ's lunch, in between classes, or any other time of the day when you are able to tal k to your friends you can also talk to God, and you can talk to your friends about God. Kids all over the country are takin g advantage of opportunities to tell their classmates about GodÂ's love. When your friends are talking about there newe st CD, I-pod, or the coolest web-site theyÂ've seen, you can use that time to tell them the good news of Jesus.

Not only will the school allow you to pray during these times but, in case youÂ're wondering, you can read your Bible in s chool as well. In fact youÂ'll find a copy of the Bible in just about every school and public Library across the nation. No one in America has outlawed prayer or the BibleÂ...not even in the public school.

Personal prayer never has and never could be outlawed in public schools the first amendment to the Constitution gives us the right to religious freedom in this country. Students can pray and read the Bible. The law is clear on this point, and we are unable to point to any credible authority on either side of the issue that thinks otherwise.

Religious activity in the public schools has been growing in recent years. In the last several decades many religious groups have placed increased interest in student evangelism, and have established thousands of prayer and Bible study clubs in the public schools. Such activity is protected, as it should be, by the Equal Access Amendment, which guarantees students the right to form religious clubs to the same extent they have the right to participate in other extra-curricular activities They canÂ't make you pray, but they wonÂ't keep you from praying either.

This case first came to court in 1962 and twenty-eight years later there was a group of teens who gathered for a retreat. During the retreat they felt burdened to pray for their fellow students. They gathered around the flagpoles of three separ ate schools to pray. The teens prayed for their friends, the school, and school leaders.

God birthed from this the idea that has come to be known as, "See You At the Pole." On September 12, 1990, 45,000 teenagers gathered at the flagpole in four different states to pray before school started that morning. One-year later one million students from Boston to California gathered at 7:00 a.m. to pray prior to the start of school. This ministry has cont inued to grow over the years since. Now more than three million students from coast-to-coast and around the world gath er to pray one day a year.

Students not only meet once a year at the flagpoles of their schools but there are more and more school football teams t hat will gather for student-led and student-initiated prayer at high school football games. This shows that there is a desir e to be able to pray at school. The Congress may have removed the traditional time of prayer that was observed during t he school day but students have found other ways to include prayer and God in their school day. Proving, like Daniel, if you want to prayÂ...nothing can stand in your way.

Thank you for your answer to my post. Blessing to you in abundance as this day goes on.

I lived in Windhoek, the capital of Namibia for 10 years from January, 1988 to December 1997. I was a radio announcer and a TV presenter in that country.

One day my husband and I cleaned out our cellar, which we used as a store room. We put all the stuff out on the sidew alk for the trashman to take away. It was a HUGE pile of JUNK.....to us anyway..... My husband and I were flabbergast ed to see some poor black people rummaging through that "trash". There was a bucket amongst this stuff, that had a hu ge hole in the bottom of it. In fact, I could say that almost the whole bottom was out of this bucket, but I saw a man take that bucket home with him. Within 24 hours, that whole heap of "trash" was taken away by the poor people and not eve n a piece of cardboard was left for the trashman to collect. Seeing that was a humbling experience and it taught me to t hank God daily for what I do have. It also taught me not to complain about the modern conveniences I wished I had, but didn't. Here in America I actually own a dishwasher. I never had one back home and my children always did the dishes in the evening after dinner. Oh, they complained bitterly, so I made a deal with them - I said "Ok, you cook the dinner and I will do the dishes." That worked well for many years. ;-)

Malawi is a truly beautiful country. I am glad you got to see it. What did you think of the things that happened in Rwand a and Burundi? Did you see the movie "Hotel Rwanda"? I would also recommend that all people living in America read the book by an American journalist, Keith B Richburg called "Out of America". One of the last sentences in this book go es like this "Thank God my ancestor got out.".
