I just heard a very interesting sermon (yes, on sermonindex) about a person who was a heathen and got married to two women. He later became a christian, and the preacher was saying what he thought he was to do.

So before I tell you what he said, I am just wondering what are your opinions? Does he get to keep both of them, or does he divorce one or does he only get to keep one but not divorce the other, basically condemning her to a life of singleness?

If we are to give spiritual counseling to this man using God's Word, I believe the first question he would need to ask himself is which one did not God tell him to marry? Did he tell him to marry the first, the second, either one of them, or neither of them? In view of the scriptures I believe we can safely say, if these marriages took place after the New Covenant, God did tell him to marry both of women and possibly neither one. If God did not join either together then he would need to divorce both of them to be in keeping of what God has joined together. What God hath joined together let no man separate. In the scriptures the Church is "the Bride and Christ is "the Bride Groom" of the Church. This is a marriage covenant in the scriptures. He must cleave to her and her only and she must respect HIS authority. When a man loves a woman as Christ loves the church, then the woman would not have a problem with submission. When both people do it as the Word says, it works. A Christian man is to love his wife as Christ loved the church and gave HIMSELF for her. This would not be possible for a man to accomplish having two wives. That's why Jesus in a Christian life must be first and foremost. If Jesus is not first and foremost in our lives we are committing spiritual adultery. I know a man who has been married to 3 wives. 12 years to the first, 1 year to the second, 20 years to the third only the last marriage of 20 years and the one that what requested in prayer has any of the marriages been effective a healthy relationship with each other and in putting Christ first in our marriage. Many times we do not ask HIM whom we are to marry then we don't want to wait for the answer and to be joined to the person and that is why we have so many divorces. There are many sins we cannot go back and fix. If committed a sin and we killed someone, we could get forgiveness but we could not bring them back, but we could get HIS forgiveness. If we steal something we can be forgiven. When a woman makes the mistake of having an abortion she can be forgiven even though she can't go back give birth to the baby she aborted, if we marry a person God has not chosen we can be forgiven. Often in an earthly sense we cannot fix or change what has happened in the past and it causes pain for many people but he can fix it with HIS forgiveness. If we confess our sins he is faithful and just to forgive us and to cleanse us from all unrighteousness. He did come for the righteous but to save sinners, it is not the healthy that need a doctor but the sick needs the great physician. Only the people that have sins can be forgiven. I know I don't love the Lord as I need to love HIM, but I want to, is it possible to love HIM as much as He loves us? I don't think so.

Well, if he was a heathen when he got married to these two women, it's safe to say that God did not tell him to marry either one - he did so by his own choosing. And it's also safe to say that God forgave him since he did not know until he became a christian that what he did was not according to scriptures, but the question still stands, does he get to have two wives after that? If all 3 are converted and both wives love him, is he allowed according to Scriptures to keep them both?

The preacher I heard said that he only gets to live with one, (I'm assuming he meant just to separate physically from the other and not divorce her since that would be against the bible), and also have limitations on what he can be in the church (for example the Bible says that an elder must be the husband of only one wife, therefore this individual could never be an elder).

Anyways, I'm not in a position where I feel a burden to reach a conclusion in this matter, since I am not a pastor to which this issue has been brought, nor am I looking for an argument, but just contemplating the Christian approach to certain scenarios for which I know the Bible has an answer, I have found that has helped me understand God better.

I would say that he has to remain married to the first one he took as his wife.....and as regarding divorce, there is scripture in which men put away UNLAWFUL wives (Ezra 9-10). God hates the putting away of COVENANT spouses (see Mal. 2---the wife of one's youth).

It is my belief that God joins the first marriages of ALL people---unbeliever and believer. Coming to faith later is important in regards to putting away unlawful relationships---adultery, fornication, incest, multiple marriage partners, etc. Salvation does not change a sinful relationship into a lawful one, so in this case, having a second wife is now akin to Adultery against the first, per Jesus' teachings on one man/one woman FOR LIFE.

Yeah, it was an example brought up in one of my missions class for us to understand the importance of how we need balanced teaching in missions.

In the example, they over-emphasized the polygamy issue, and ended up neglecting the need to take care of these women. They had outwardly converted these men to Christ in their actions, but not converted their hearts.

Now the question would be, is it better to tell a man, 'get rid of your extra wives' or 'keep your wives, but make sure that your children only have one wife or husband.'

It's about interpreting our Western church culture as correct. If you read the verses about deacons and elders in the NT, the requirement says 'a husband of but one wife.' Now this makes a strange assumption, that there are those in the church with more than one wife!

It wouldn't be a requirement if it didn't in fact separate.

Now it doesn't say, 'having more than one wife is wrong.' In fact, it may have simply been an assumption that if you have more than one wife, you have more people to feed and take care of, so you shouldn't be serving as a deacon.

But since we read that verse through the lens of our Western church cultures, we automatically assume that all it really says is men shouldn't have more than one wife.

Now I don't support polygamy in modern American culture... but there was a time and place in history where it was acceptable practice.

Even now in some parts of the world, women outnumber men 4 to 1 (namely in the middle east). And if a woman wants security and provision for her needs, she has to become a second or third wife to a man who is already married.

If we look at human history, there were many times that men were killing each other over resources or territory, and they left their women and children to fend for themselves.

We automatically look at a man with more than one wife as if it's a sexual issue. In some cultures taking another wife was a sign of charity and good will. Especially if that wife was the widow of a relative.

Now our world is experiencing something entirely new, in some parts of the world, for the first time in human history there

There are more men than women (India and China as examples) which is going to cause a lot of interesting events in the future.

When in Uganda in the 1970's we knew many brethren who had been saved and blessed in the 1935 East African revival.

There was a man and his wife who was a special friend of ours, and one of the leaders in that area. His wife was also a godly woman. But he had another wife (he'd married both before he was saved). She hadn't yielded to the Lord, but lived nearby in her own house, (I met her).

When Jeremiah was saved he prayed about what to do and believed that he should keep Eleanor as his wife and cease to live with the other lady. But he did continue to support her financially.

I haven't heard of anyone neglecting the wife that was put aside - or that missionaries encouraged anyone to do so.

But in some countries and societies having more than one wife is part of the culture - if a man can afford it - or even "required" of a king or chieftan.

I agree that it's important for an elder or deacon to be "above reproach" in this area, but I'm certain the Lord doesn't condemn polygamy as such, if a man is saved when in that situation.

After all, the OT kings - even the best of them - had more than one wife, and the Lord didn't forbid it, any more than He forbade slavery.

Here's an interesting thing somebody pointed out to me a while ago that I never picked up on.

1 Corinthians 7:10,11 “To the married I give this command (not I, but the Lord): A wife must not SEPARATE from her husband. But if she does, she must remain unmarried or else be reconciled to her husband. And a husband must not DIVORCE his wife."

I was asking an older person from church if God still requires a christian woman, for example, who became christian after she was married, to remain with her abusive husband who is not a christian and who does not want to divorce her.

The answer he gave me was interesting and he pointed out to this verse that said, the woman can SEPARATE, in other words, remove herself physically from her husband, without divorcing him. And if her husband falls into sin, then she is free to remarry. So this is basically God giving the woman a way out if she is being abused physically.

But this is no way a means for a woman to get out of her marriage if she doesn't like her husband any longer, because a verse 10 said, "To the married I give this command... A wife must NOT separate from her husband."

Interesting response, because I thought being "separated" and being "divorced" meant the same thing.

Hi Alin,

I disagree with you. I haven't read all the responses yet, but I'm sure someone has already said what I am going to.

If a wife (a second) comes from an unlawful marriage (never having been in a covenant marriage herself), she is FREE to marry another, since her vows were not taken lawfully to begin with. The only divorced woman who is prohibited from marrying again is one who is bound to her covenant husband until death (Rom. 7:2-3, I Cor. 7:39). A woman who is committing adultery in the Lord's sight (by entering into an unlawful marriage with a man who already has a wife) is NOT bound to him---he already has a wife he is bound to.....Blessings.....

That would be Deut. 24:1-4.....since Jesus said Moses granted divorce for hardheartedness and since the beginning this was not so, Jesus was abrogating this "permission". Instead of a remarriage being lawful, Jesus taught that anyone who marries after a divorce is committing adultery, not entering into a lawful marriage (Mt. 5:32, 19:9-10, Mk. 10:1-12, Lk. 16:15-18, Rom. 7:2-3).

For a couple who enters into an adulterous union to repent of that union is nowhere forbidden by Jesus. As a matter of fact, forsaking sin is called for by Jesus. Just as He told the woman caught in adultery to "go and sin no more", so it is with those who are caught up in adulterous unions. His desire is for them to forsake their adulteries and sin no more.

We only know that those with more than a wife could not be spiritual leaders in the church and I presume that even if the husband didn't live with his 2-nd wife, he provided for her and their children. But there is no evidence that the apostles told the newly converts to separate from their 2-nd wives...

Hi Zeal,

Yes, this issue brings up many questions. Unfortunately, most will not seek out the full truth in the WORD, but instead heed what their pastors teach (all different teachings, by the way), relying upon them for Truth.

As for "lawful"/"unlawful" marriages, as you said, you are already seeing that just because a government sanctions a union, does not mean that God does ;-). follow this thought out with those unions Jesus has said are adultery.....and really ponder what Rom. 7:2-3 means in light of this.

Concerning "I hate divorce".....you must read that passage in context (Mal. 2). God is dealing with a man who puts away his COVENANT wife(the one God joined him to as ONE) and then the man marries another.

As scripture shows, there ARE marriages that were put away as acts of REPENTANCE---because the people had disobeyed God in marrying (Ezra 9-10). The divorces in those cases were not sin, they were acts of repentance. Such would be the case today with homosexual marriages, adulterous marriages, and incestual marriages. To "divorce" in such cases would be the fruit of genuine repentance, it would not be sin, as God did not join those unions. The only sin is when man tears apart what GOD joined together (any first/covenant marriages). Blessings.....

In such cases, vasilef, we can only go by the teachings in scripture. Jesus made it very clear that a man was to only have ONE wife, and for a wife, only 1 husband. This is the creation intent for marriage which He reinstated. Jesus did not sanction for a man to have 2 or more wives. Any relationship other than with one's first wife is adultery. Many things were "tolerated" in the OT times, but those same things are no longer permissible per Jesus.

If we are to believe that polygamy is still ok/tolerated by God, because of the hardships involved with forsaking such relationships (using that as our reasoning and ignoring Jesus' teachings on one man/one woman for life), then we open the door to any illicit relationship being tolerated in the church because forsaking such relationships may be hardships on those involved.

As to the meaning of "husband of one wife" there has been much discussion on what exactly this means. I have looked at the culture of that time in the writings of the Early Church Fathers and divorce/remarriage was NOT an issue in the Gentile culture. Matter of fact, it was RARE, so I don't believe that is what it was speaking of. I also can't find evidence of polygamy being something very commonly found either.

As much as I hate to say this, I believe the RC church is right on their interpretation of that passage---that having only one wife, means that a man cannot fill such a position if he marries again AFTER the death of his covenant wife. To me, it doesn't seem "fair", yet, I understand how Paul/God wanted men in leadership that personified God.....God only has one bride for ever. In this culture of divorce/remarriage, people looking down on singleness, they have said such standards are almost impossible to fulfill.....I say, yes, probably, but in Paul's day, fulfilling such standards were not "hard".

We also have to look at this as a big picture: is it EVER ok to divorce one's covenant spouse and then marry another person? I don't believe so, so the "standard" of just the elder not being divorced/remarried does not make sense. God doesn't want ANY of His to be involved in sin, not just the elders. In the same way, if polygamy is sin, then NONE of those who name Christ should be involved in polygamy. So again, we must look at "husband of one wife" as a picture of the PERFECT image of God---who only has ONE wife---for ever. Blessings.....
