Hello...

My wife has been a teacher in public high schools and universities for over five years. However, she has been teaching at a private, Christian school for nearly a year. She enjoys the experience of working with young children without having to instruct them.

Recently, the owner of the school gave the teachers a book entitled 23 MINUTES IN HELL. The teachers are supposed to read the book and discuss it at a meeting next week. My wife asked me if I had read the book. I admitted that I had thumbed through it several times, but have never felt a desire to actually sit down and read it cover-to-cover. Why? While it's story about the terrors of Hell sound plausible, it just seems that the story contradicts some basic understandings about Hell -- while also adding some things that the Word of God is decidedly silent about.

The book, written by Bill Wiese, chronicles the author's tale of having visited Hell for 23 minutes. It is a fantastic-sounding tale about a man's supposed voyage to Hell and back. It is actually (https://www.sermonindex.net/modules/myvideo/photo.php?lid668) included here on SermonIndex as a video sermon.

Personally, I have a problem with this tale. II Peter, Luke and Psalm mention that Hell was created as a "dungeon" for f allen angels who are literally kept in chains. Of course, we know that fallen man will ultimately share this place with the m. The Bible talks about the "slandering of angels" or "spiritual beings" and "dignities" (such as in II Peter 2:1-12). In fa ct, Jude 1:8-11 says that not even Michael the Archangel spoke against the devil with slanderous accusations.

I have read quite a few stories from different preachers who claimed to have visited Hell. Most of their stories seem to c ontradict one another -- especially on the details. Dr. Richard Eby, Mary Baxter, and many others have written and earn ed lots of money from books about their supposed journey. While the story written by Bill Wiese sounds somewhat famil iar, it contradicts nearly every other story that contains "specific" information about each author's supposed "journey."

What do you think? do you think that guy is telling the truth? Is he making it up? Did Wiese have a legitimate and/or s pooky dream...and then start stretching that dream into a novel?

Regardless, I know that Hell can only be WORSE than any story written by men. My wife began reading the book...and doesn't want to finish it. She has already found many passages within the story that she feels are either unscriptural or extra-scriptural.

I am interested in the opinions of the brethren here on SermonIndex. Of course, I am not trying to start a debate. I am j ust trying to see if anyone has an opinion on the matter. Thanks!

When I watched his video presentation given a t a Church; his attitude was one of lightness and some levity. Hello...

Of course, I do believe in the reality of Hell and an eternal punishment. I also believe that God could give people a glimpse of such a place. However, there are so many conflicting accounts. Mary Baxter's account differs from the account written in 23 MINUTES IN HELL. This account also differs from the account recorded in Dr. Richard Eby's book, CAUGHT UP INTO PARADISE. Either one is right and the rest is wrong...or they are all wrong.

I have trouble with the account found in the book. It is a narration that seems decidedly extra-Biblical. We can argue that the book will serve to warn people and lead them to Christ...but what if the book is a lie? What if it is a pure lie or exaggeration written by a man who has a motive to keep people from Hell? Mary Baxter's A DIVINE REVELATION OF HELL is filled with strong detail that might warn people about the result of dying without Christ -- but her book is a direct contradiction of Bill Weise's 24 MINUTES IN HELL.

The Scriptures are clear that Hell exists...and that it is a place of torment. Yet the Scriptures are lacking in the details. We have Jesus' account of the Rich Man and Lazarus, but that is pretty much it (as far as specific details). Now, we have men and women who are writing 180 page books about the subject -- filled with conflicting details that are not found in the Word of God.

Anyway, I don't know what would cause a "successful" man like Wiese, Baxter or Dr. Richard Eby to *lie* with their accounts. However, two (or all three) of them are obviously lying. I wonder.

The rich man begged Abraham to send Lazarus to warn his brothers about Hell. Abraham replied, "If they hear not Mos es and the prophets, neither will they be persuaded, though one rose from the dead" (Luke 16:31). It makes me wonder why God now decide to use such exclusive, extra-biblical narratives from people who claim to have visited the afterlife.

I wonder if it is wise to allow this book to go unchecked (or to consider it "true") simply because we think that it serves to warn unbelievers?

When Bill and his wife first began to speak publicly, they paid ALL travel expenses out of pocket.

They are quiet and humble people and not showboats by any means. I could understand why after speaking to numerou s congregations, that mentioning of seeing the Lord will not always be as poignant as the beginning because it would have been repeated often and I can understand how it would appear that he was being casual.

I certainly understand your concern. Yet, I suppose that someone else could say the exact same thing about people who are so quick to embrace something without faithfully testing the claims (rather than a quick consideration of apparent "fruit").

The point that I was trying to make is that there are MANY people who have made claims of visiting either Heaven or He II...or both. Of course, all of them have described Heaven as a wonderful place and Hell as a terrible place. Yet the only thing that seems to be common in most of their stories is that their stories all seem to contradict one another. Dr. Richar d Eby (a doctor who died after falling from his balcony) spoke of both Heaven and Hell in a way that contradicts Bill Wies

e. Mary Baxter (in her book *A Divine Revelation of Hell*) claimed to have visited Hell on several occasions, and her stori es are also in direct contradiction with the claims made by Wiese. Many other people have claimed conflicting tales of vi siting Eternity and then returning. Some of them are OBVIOUSLY false (like Jesse Duplantis's ridiculous "Close Encounters of the God Kind," in which he claims that he has Gucci furniture in his eternal mansion, a picture of Mary and baby J esus in his heavenly bathroom, the souls of unborn and aborted babies asking God that they can be born on Earth and g othic-clad angels playing heavy metal rock-n-roll before the throne of God).

Now, nearly all of these tales (about trips to Heaven or Hell) all seem to "inspire" fruit where people consider life after de ath. Yet some of them are false. So, are they truly bearing godly *fruit*? If so, is this even the type of fruit that would cau se a person to remain in Christ Jesus? Remember, the rich man begged Abraham to send a person from Heaven or Hel I back to life in order to warn his brothers. Abraham's reply? No, because, " *If they hear not Moses and the prophets, n either will they be persuaded, though one rose from the dead*" (Luke 16:31). Paul spoke about a man (possibly himself) who was caught up into the third heavens and saw things "which it is not lawful for a man to utter" (II Corinthians 12:1-4).

Sister, I am NOT saying that Bill Wiese is being untruthful in his claims. I am only beginning to look through his book an d audio/video testimony in order to "test" his claims. The one problem that I already can see is that many of his claims c annot be verified by the Word of God. Yes, we know that Hell is a very real and very terrible place. Yet, Bill Wiese goes into specifics that are NOT included in the Word of God. Thus, many of the claims within his book cannot be tested by t he Word of God because those claims are extra-Biblical. This is true of nearly every other claim made by people who tel I stories about trips to Heaven and/or Hell.

Yes, many Christians can be "far too quick to judge." But is this what we are doing? Perhaps we are not quick enough to TEST. Paul encouraged us to do this in I Thessalonians 5:21. While we aren't necessarily to judge the heart of the man or his motives, we can test the claims. This is quite different from "fruit inspecting." I've noticed that some people are far too quick to also point out "good fruit." In spiritual terms, I have known some people who have a difficult time telling the difference between a cherry and a crab apple. Worse, there are "fruit" that appears lovely at the time but can be pois onous (or even deadly) if consumed.

A former professor of mine wrote a book that examines many of the claims made by people who speak about visiting Et ernity and returning (along with other widely publicized claims of the supernatural). Dr. Bill Alnor wrote *Heaven Can't W ait*. Dr. Alnor, who served as a pastor of a Calvary Chapel for several years, shows how many of these claims strongly c ontradict one another. In fact, he even shows how some of the people actually contradict themselves with each subseq uent telling of their story.

In regard to the purpose of this thread: My wife was assigned to read 23 Minutes in Hell by the owner of a Christian scho ol where she works as a teacher. When my wife met with the owner, she explained her hesitation about embracing man y of the specific claims found within the book. My wife explained her view that Hell can only be described as a terrifying, eternal place reserved for people who do not know the Lord, and that this is already clear in the Word of God. My wife f urther said that she didn't really need a book to describe the precise details of a place that she already knows is horrible from the Word of God. The owner kindly agreed.

Anyway, I hope that you don't view this thread or the underlying question as an affront upon Bill Wiese. I don't know the man (or much about him) to even want to do that. Rather, my wife and I were inquisitive about this man's specific claims, and what others think about so many often-conflicting tales of visits to Hell (or Heaven). Since we had not read the book at the time, we weren't sure what to think. We have since read through the book and have already found some issues with certain specific claims. This wasn't meant to cast a reflection upon Bill Wiese at all, but just as a request for advice from anyone who might have been more familiar with the man's claims and had tested them by the Word of God.

As I said before, many of his specific claims cannot be verified by the Word (since the Word does not go into nearly as much detail about the layout of Hell as Wiese does). After my wife has (and to a lesser extent, I have) looked through the book, we do have some concerns with certain specific claims, which could potentially call into question the entire account.

The only concern with this is that the same thing could be said of MANY of the people who claim to have visited Heaven or Hell...but whose story directly contradicts with the testimony told by Bill Wiese. For instance, the stories told by Dr. Ri chard Eby and Mary Baxter are in direct contradiction with the story told by Bill Wiese. All of these supposedly show "fru it" in a broad sense of the word. All three of these individuals "urge" others to consider life after death and also "urge" th eir readers/hearers into repentance. Yet, due to the contradictions, at least two of these individuals are not telling the tru th.

Much more importantly, the specific details as described by Bill Wiese cannot be verified by Scriptures. Now, this is not to say that it did not happen. Yet, the tales of individuals who supposedly visited Hell seems to be in contradiction with the Scriptures that I mentioned earlier.

The Bereans were counted as being of more noble character since they searched the Script ures to see if what Paul was teaching was true. Yet we can't really "test" these stories with Scripture. Why? The Script ures are decidedly vague in regard to the specific details about Hell (at least, compared with the precise details that Mar y Baxter, Richard Eby, Bill Wiese and others have provided).

Do you see the problem with quickly embracing such a story? If the Bereans were considered "noble" for testing Paul's words, I believe that God expects His children to test the claims of others. There is no need to "convince" anyone of such a story that cannot be entirely verified by Scripture.

In fact, I believe that we should not be "convinced" of ANYTHING until it is verified by Scripture. The burden of proof (so to speak) isn't on people to prove his claims as being false, but on believers to verify the truth BEFORE they are willing to embrace such a testimony. So far, I haven't found anything in this story that makes me embrace Bill Wiese's claims. If am certainly not passing judgment on the man himself. His relationship with Christ is, of course, between him and the Lord (and, to a much lesser extent, the people that he preaches to). I would simply urge all believers to "test everything" and only hold onto the good (I Thessalonians 5:21).
