#### **CNN: Was Jesus Wealthy?**

Each Christmas, Christians tell stories about the poor baby Jesus born in a lowly manger because there was no room in the inn.

But the Rev. C. Thomas Anderson, senior pastor of the Living Word Bible Church in Mesa, Arizona, preaches a version of the Christmas story that says baby Jesus wasn't so poor after all.

Anderson says Jesus couldn't have been poor because he received lucrative gifts -- gold, frankincense and myrrh -- at bi rth. Jesus had to be wealthy because the Roman soldiers who crucified him gambled for his expensive undergarments. Even Jesus' parents, Mary and Joseph, lived and traveled in style, he says. ...

I think part of the problem lies in our own perception of what wealthy is. We so often equate the term wealthy with a self -satisfying and greedy accumulation of money and goods. We often think that if a person does have ample means then that person's heart is given over to greed or to a love of money.

I do believe Jesus had not only had enough resources to see His own needs and those of His traveling companions met, but had ample supply of resources to give liberally and generously on each occasion. There are several clear scriptural passages that seem to indicate that Jesus had access to as much financial provision as He had need of. I will give two notable ones.

#### Mat 27:55-57

- (55) And many women were there, watching from afar off, those who followed Jesus from Galilee, ministering to Him;
- (56) among whom was Mary Magdalene, and Mary the mother of James and Joses, and the mother of the sons of Zebe dee.
- (57) And evening having come, a rich man from Arimathea (Joseph by name) who also himself was discipled to Jesus,

Jesus had more than 12 disciples who regularly accompanied Him and supported His ministry. His disciples included w omen and men who were wealthy in their own right. These minister to Jesus. How? I believe just as Paul speaks of ch urches ministering to himself financially.

#### Joh 13:29-30

- (29) for some thought, since Judas held the moneybag, that Jesus was saying to him, Buy what things we have need of for the feast; or that he should give something to the poor.
- (30) Then, receiving the morsel, he immediately went out. And it was night.

How many of us give to the poor so regularly that if we were to suddenly arise from the supper table at night and leave, it would be assumed that we were once again going to give to the poor? Obviously Jesus, from His own ministry resources, gave so frequently that this was the assumption of the rest of the disciples when Judas suddenly rose and left AT NI GHT.

What we must realize is that Jesus related to money correctly. He rightly saw its proper and Biblical purpose. Money is simply a tool to be used to accomplish eternal objectives, not a thing to be sought after as an end in itself. It is interesting to note how often money is the topic of teaching in the New Testament. God desires us to relate to money properly.

We know very little of the bulk of the life of Jesus. We see Him mentioned at about age 12 and not again until about age 30 when His three years of ministry began. I have heard several theories about the interim period, but nothing concrete. We don't find any mention of Joseph being around during the ministry years. One might assume he had already died, a nd if so the gifts from the Magi no doubt sustained the family. I have heard some claim that Joseph of Arimathea might have taken Jesus under his wing so to speak, being a relative of Mary, after Joseph died. But all of this is surmising about something that, unfortunately, history does not clearly record.

It is true that Jesus did not own any real estate during his three years of ministry. He spent those three years living a v ery itinerate lifestyle. This does not mean that he was poor in the sense that we think of poverty. Many of us, I think, se e Jesus and the 12 a bit like a traveling band of nomadic, homeless people without a penny to their name. A bit like hipp ies (those of you from other nations might have to research that one). I believe that if you study the word carefully, this c annot be the case.

The point is that there are those who relate to and use money Biblically, and those who don't. I recall hearing a man talk about his good friend. This friend had a nice estate, raised thoroughbred horses, had cars, boats, and other things we w ould look at a frivolous toys. One day a person, learning that the friend was a believer, began lambasting this man. "Ho w can he even call himself a christian and live such a lavish lifestyle." The man said, I had to bite my tongue. I could no t reveal things about my friend that were privileged information. He said, "My friend lives on 10 percent of what he make s and sows the other 90 percent into the ministry." I would never judge another man because of his financial standing. God will judge that. This man related to money in a very Biblical way and used 90 percent of what he had for the kingdo m of God. I don't do that. I honestly don't think right now that I have the faith to do that.

There are those who are greedy and are "raping the Church word-wide", and we a Christians who see clearly that this is going on need to stop funding these thieves and encourage others in the body to do the same. Give in good ground wh ere men and women have a proper Biblical perspective on money and handle it according to the dictates of the word of God and the leading of the Holy Spirit.
