# ELEVEN CHRISTIANS ARRESTED, JAILED, AND CHARGED UNDER HATE CRIMES LEGISLATION 10/11/04

PHILADELPHIA - On Sunday, October 10, 2004, eleven Christians with the Philadelphia-based Repent America were ar rested, jailed, and charged under hate crimes legislation during an evangelistic outreach at the annual "OutFest" homos exual pride event held in the public streets of Philadelphia.

The six men and five women representing Repent America approached the event and were immediately confronted with unlawful opposition by a group of homosexuals. This group, the "Pink Angels", was formed by homosexual attorney C huck Volz, a senior adviser to Philly Pride Presents, organizers of the annual OutFest event which receives \$22,500 yea rly from the City of Philadelphia. The "Pink Angels" blocked access to Repent America by forming a human chain, ref using to allow the Christians to walk down the public sidewalk. Police intervened shortly thereafter, escorting Repent America through the human blockade.

While on the public sidewalk and street inside the event, Repent America began to open-air preach with the use of Scrip ture banners, and to distribute Gospel literature, as members of the "Pink Angels" blew loud whistles and carried large si gns alongside the Christians to block their message and their access to the event attendees, while others screamed obs cenities. The police refused to take action as the Christians were continuously followed, obstructed, and harassed.

Repent America obeyed all laws, and even the unlawful requests, to move by the Philadelphia Civil Affairs police officers in an effort of cooperation. Regardless of Repent AmericaÂ's compliance, Chief James Tiano, head of the Civil Affairs U nit, without warning, ordered the arrests of the Christians and hauled them off to jail, where they spent 21 hours, before being released the following day. Ten Christians were individually charged with three felonies and five misdemeanors, w hile a teenager with the group was charged with a misdemeanor.

"This is one of the most remarkable and unlawful actions by police that I have ever witnessed. Their blatant disregard o f the law by allowing hecklers to impede our way, block our message, and then arrest us, is inexcusable, especially by p olice officers who are specially trained to protect civil rights," stated Michael Marcavage, director of Repent America. " Christians are now being labeled as 'hatersÂ' and any speech that homosexuals perceive to be intimidating, such as o ur Christian witness at OutFest, makes them a prime target for 'hate crimes legislationÂ'," Marcavage continued.

The three felonies and five misdemeanors include: Criminal Conspiracy (Felony), Possession of Instruments of Crime ( Misdemeanor), Reckless Endangerment of Another Person (Misdemeanor), Ethnic Intimidation (Felony), Riot (Felony), Failure to Disperse (Misdemeanor), Disorderly Conduct (Misdemeanor), and Obstructing Highways (Misdemeanor). Â"W e are clearly Â'not guiltyÂ' of these crimes, and with the help of our video footage, we shall be vindicated of these trump ed up charges,Â" Marcavage concluded.

The Christians are scheduled to be arraigned on October 18, 2004 at 8:00AM in the Philadelphia Criminal Justice Cente r.

Christians Jailed In Philadelphia For Preaching God's Word October 11, 2004

The City of Philadelphia has shown itself intolerant of the Gospel and those who proclaim its message.

On Sunday, October 10, eleven Christians were arrested on the streets of Philadelphia as they shared the truth of the S criptures and called upon hundreds of celebrating homosexuals to repent and believe the Gospel.

On the first day of the "REPENT AMERICA LIFE AND LIBERTY TOUR" eleven Christians took the Gospel to the Philad elphia Outfest Homosexual Pride Event. The Christians displayed banners with Biblical messages and began to preach t he gospel to those in attendance. The event took place on a public street where thousands were milling.

The ministry team was immediately accosted by the "Pink Angels", a militant mob of homosexuals who attempted to dro wn out the call to repentance with dozens of loud whistles, and sought to hide the message with dozens of large sheets of pink styrofoam.

Even though the Christians obeyed all laws, city ordinances, and lawful requests by the Philadelphia police officers on h and, they were promptly and without warning, arrested and hauled off to jail where they spent 21 hours before being rele ased on Monday morning.

Among the outrageous charges filed against these faithful witnesses were the following.

-Criminal Conspiracy, felony

-Possession of Instruments of Crime, misdemeanor (The Bible is a two-edged sword and was considered a threat to the lawless and ungodly)

Reckless Endangerment of Another Person, misdemeanor (This was entirely dreamed up)

Ethnic Intimidation, felony (Sodomites have worked for years to have clear Gospel preaching outlawed as a hate crime.)

Riot, felony (Dispite the fact that our behavior was above reproach and we were attacked by a mob of whistle blowing, o bscenity screaming God haters, the Christians, and only the Christians, were charged.)

Failure to Disperse, misdemeanor (This charge is also bogus)

Disorderly Conduct, misdemeanor (A favorite allegation made by those who have no truly lawful charge to bring against those who would obey the great commission.)

Obstructing Highways, misdemeanor ( Once again this charge is ridiculous. A video crew was on hand to film the ministr

y outreach and the footage will clearly disprove the validity of every charge brought against us)

"The Scriptures are filled with accounts of faithful followers of the Messiah who proclaimed the Gospel dispite severe per secusion. We are called upon and commanded to do no less. To shrink back would not be Biblical Christianity. May all o f the true Disciples of our Messiah live as he lived and obediently follow Him even as this world grows in its hatred towar d the truth of the Gospel and toward His servants." said Dennis Green, director of Life and Liberty Ministries.
