He also said if your are not living a life that is righteous and are having problems with sin, it does not matter because Go d sees you as perfect anyway and it only means that you are not recieving all that you could.

To put this into context, the church has come from a strong Pentecostal properity background, notice the focus on "recie ving". His assistant pastor the following week made the statement in keeping with the pastors teaching. "God only sees y our destiny"

I sent him an email requesting we chat stating that if sin is of no matter in the the new testament then we would need to t ear out most of Pauls letters as most of them had warnings and instruction about sin in the church.

His response was to graciously let me know he is willing to unpack John 16: 8-11 for me (to understand conviction of si n before and righteousness after?). Obviously there is no support for this in context or even infered.

I would greatly appreciate some information on the erroneous use of this text and where it has come from as I wish to as sist this guy to see the problem with the Disney or soft gospel. i am aware of the Once saved always saved teaching, ho wever this is taking things to a whole new level.

Wombat and Matthew, telling us what a particular speaker at a particular Church believes in a discussion about what he conceives what the Holy Spirit does or does not convict has no bearing on what set of Laws we Christians are under, su ch argument is a Red Herring type Sophistry.

I do not agree with that speaker based upon what you quoted him to have said. But what he said has nothing to do with what set of Laws we are under.

I am dead to the Mosaic Law, and I thank God that HE annihilated the Mosaic Law as per Zechariah 11: 7-13, upon Jes us death.

The question we are discussing is:

Are we under the Mosaic Covenant (Covenant means 'Contract'), or are we under the Laws of Moses, or are we under the Laws of Jesus Christ.

Jesus was not sent by God the Father to be our cheerleader for keeping the Mosaic Law. Jesus fulfilled the Mosaic Cov enant in our place. And Jesus took upon Himself the penalties we deserved for Breaking the Mosaic Laws.

The Scriptures are very clear about this:

Heb 7:11-22

11 Now if perfection was through the Levitical priesthood (for on the basis of it the people received the Law), what furthe r need was there for another priest to arise according to the order of Melchizedek, and not be designated according to the order of Aaron? 12 For when the priesthood is changed, of necessity there takes place a change of law also. 13 For the one concerning whom these things are spoken belongs to another tribe, from which no one has officiated at the altar. 14 For it is evident that our Lord was descended from Judah, a tribe with reference to which Moses spoke nothing concerning priests. 15 And this is clearer still, if another priest arises according to the likeness of Melchizedek, 16 who has become such not on the basis of a law of physical requirement, but according to the power of an indestructible life. 17 For it is attested of Him,

"YOU ARE A PRIEST FOREVER ACCORDING TO THE ORDER OF MELCHIZEDEK."

18 For, on the one hand, there is a setting aside of a former commandment because of its weakness and uselessness 1 9(for the Law made nothing perfect), and on the other hand there is a bringing in of a better hope, through which we dra w near to God. 20 And inasmuch as it was not without an oath 21(for they indeed became priests without an oath, but H e with an oath through the One who said to Him,

"THE LORD HAS SWORN AND WILL NOT CHANGE HIS MIND, 'YOU ARE A PRIEST FOREVER'");

22 so much the more also Jesus has become the guarantee of a better covenant. NASU

The words in the Bible mean something people, when taken in proper context. Please note Hebrews 7:12.

And it will do you no good to pick and choose what part of the Mosaic Law you wish to keep, such as the Ten Command ments, on what basis are you discarding the other 603 Mosaic Laws. Did Jesus keep the the other 603 Laws for you.

What are you thinking. You are rejecting the salvation that Jesus won for us on the cross, God's gift to us who are saved through the Finished work on the cross on our behalf, we who have faith in what Jesus accomplished for us, for we who actually believe God.

And anyone raising 'Antinomianism (No Law)' is deceiving such people are trying to steal away your liberty and what Go d has already accomplished for you, if indeed you believe Him and His WORD.

The Catholic Church created this false argument against Luther and others to undermine their preaching salvation by Fa ith in Jesus Finished work on the cross, rather than the RCC's salvation through Sacraments, Luther (and others) correctly argued that we are not under the Mosaic Law.

- 3. The Law of the Spirit Of Life in Christ, walk with God daily and 'God in me' The Holy Spirit will transform your very n ature via our daily walk with God, and pray for us even with prayers we often do not realize we need to pray.

These 3 Laws are Perfect. They put all things into proper perspective. In a sense, these three laws of Jesus Christ is ver y balanced, they are positive Laws, Laws that transform us. Laws through which we live by faith. Laws by which God ke eps us.

If God is for us, who can be against us. By the Laws of Jesus Christ we enter into daily fellowship with God, and by them God keeps us and performs His work in us.

Ro 8:1-5

This went through my mind too. Of course, the preacher may have no conscience awareness of any sin on his part, or e ven of any strategies to deflect conviction. LetÂ's admit, for a spiritual leader, conviction is infinitely more painful than fo r the rest of us. ItÂ's not merely the experience of standing naked before your people. You stand to lose your honor, you r reputation, maybe your job. That may happen when a heinous sin is exposed. But also, true confession may repel a c ongregation. People donÂ't always want honesty, brokenness, mercy, or grace to be operational in their church. They te nd to resist it. So for a pastor especially, it's as the saying goes: damned if you do; damned if you donÂ't.

The problem with the ministerÂ's theology may actually be a problem with the congregation. HeÂ's simply telling them w hat they want to hear. So, trying to change the minsterÂ's theology will get you nowhere.

I must admit, if I was the pastor, and heard words like "tear out most of PaulÂ's letters" I would probably smell a rat. I might suspect a frontal confrontation more than a pleasant dialogue. Pastors do get that a lot – and they really do ha ve to protect themselves.

Wombat, it seems you wish to discern GodÂ's call for you in this issue. It may be that the PastorÂ's decline of your offer is for your protection. What you are seeing is likely only the tip of an iceberg, and when you go after that tip without kn owing the bigger picture, you merely risk harm to yourself. You get hurt. And you end up being Â"the problemÂ".

Another point: It is worth acknowledging the morsel of truth in the pastorÂ's teachings: Yes, prior to conversion the Spirit convicts of our lostness, our separation from God (ie, sin) but afterwards the Spirit assures us of our new position in C hrist – forgiven, free from guilt and condemnation.

It is also worth remembering that the devil also tries to convict GodÂ's children — or rather, accuse them. There is a difference, and youÂ'd have to think about that too.

If God is leading you to minister into the life of this pastor, ask God to open a way to build relationship. Get to know him and earn his trust. In time, if the Spirit leads you, you can get on to theological matters that press on your heart. But tryin g to correct someoneÂ's doctrine without having any relationship of trust tends not to work.

Also making it your mission to combat a bad theology can wear you out. There are so many bad theologies out there, yo u end up beating down hordes of elephants with fly swatters.

Save your energy to grow in Christ yourself, and to build into the lives God puts in your path. Guard your peace and joy. The best way to combat a bad theology is to live a good one. What you see lacking in the other Â- live it in your own life

This is what it means to walk like Jesus, Jesus had a clear conscience before God all the time. P aul had it all the time. Why not you and I can have it? But our attitude to Sin should always be to be perfect and Holy. Occasionally we may fall, but what is our attitude?

Yes, because the power of sin was in the Mosaic Laws.

Paul stated in Romans 7 that the Law was good, but it was death to us.

Ro 7:4-8:8

4 Therefore, my brethren, you also were made to die to the Law through the body of Christ, so that you might be joined to another, to Him who was raised from the dead, in order that we might bear fruit for God. 5 For while we were in the fle sh, the sinful passions, which were aroused by the Law, were at work in the members of our body to bear fruit for death. 6 But now we have been released from the Law, having died to that by which we were bound, so that we serve in newness of the Spirit and not in oldness of the letter.

7 What shall we say then? Is the Law sin? May it never be! On the contrary, I would not have come to know sin except t hrough the Law; for I would not have known about coveting if the Law had not said, "YOU SHALL NOT COVET." 8 But s in, taking opportunity through the commandment, produced in me coveting of every kind; for apart from the Law sin is de ad. 9 I was once alive apart from the Law; but when the commandment came, sin became alive and I died; 10 and this c ommandment, which was to result in life, proved to result in death for me; 11 for sin, taking an opportunity through the c ommandment, deceived me and through it killed me. 12 So then, the Law is holy, and the commandment is holy and rig hteous and good.

13 Therefore did that which is good become a cause of death for me? May it never be! Rather it was sin, in order that it might be shown to be sin by effecting my death through that which is good, so that through the commandment sin would become utterly sinful.

14 The Conflict of Two Natures

For we know that the Law is spiritual, but I am of flesh, sold into bondage to sin. 15 For what I am doing, I do not underst and; for I am not practicing what I would like to do, but I am doing the very thing I hate. 16 But if I do the very thing I do not want to do, I agree with the Law, confessing that the Law is good. 17 So now, no longer am I the one doing it, but sin which dwells in me. 18 For I know that nothing good dwells in me, that is, in my flesh; for the willing is present in me, but the doing of the good is not. 19 For the good that I want, I do not do, but I practice the very evil that I do not want. 20 But if I am doing the very thing I do not want, I am no longer the one doing it, but sin which dwells in me.

21 I find then the principle that evil is present in me, the one who wants to do good. 22 For I joyfully concur with the law of God in the inner man, 23 but I see a different law in the members of my body, waging war against the law of my mind

and making me a prisoner of the law of sin which is in my members. 24 Wretched man that I am! Who will set me free fr om the body of this death? 25 Thanks be to God through Jesus Christ our Lord! So then, on the one hand I myself with my mind am serving the law of God, but on the other, with my flesh the law of sin.

Romans 8 Deliverance from Bondage

8:1

Therefore there is now no condemnation for those who are in Christ Jesus. 2 For the law of the Spirit of life in Christ Jesus has set you free from the law of sin and of death. 3 For what the Law could not do, weak as it was through the flesh, God did: sending His own Son in the likeness of sinful flesh and as an offering for sin, He condemned sin in the flesh, 4 so that the requirement of the Law might be fulfilled in us, who do not walk according to the flesh but according to the Spirit. 5 For those who are according to the flesh set their minds on the things of the flesh, but those who are according to the Spirit, the things of the Spirit. 6 For the mind set on the flesh is death, but the mind set on the Spirit is life and peace, 7 because the mind set on the flesh is hostile toward God; for it does not subject itself to the law of God, for it is not even able to do so, 8 and those who are in the flesh cannot please God. NASU

God did not desire to give the Mosaic Law to the peoples of the Exodus, He wanted them to walk with Him by Faith, for His very presence was visibly present. But the peoples wanted a contract with God that guaranteed long life and prosperity in return for their obedience to what He desired of them.

Messiah as Prophet

I would like to share a rather different view than yours on the importance of the Mosaic Law.

God gave Moses the Ten Commandments et. al. to give to the people of the exodus, because the people were hard hearted. God wanted them to trust not their own understanding, but to walk with Him by faith as their father Abraham did, and not by sight. They did not know how to walk and live by faith; they wanted a visible clear contract so they would know exactly what God required of them in order for them to receive all of His blessings. Indeed, they received this Law most enthusiastically, declaring at least twice "All that the LORD has spoken we will do!" and entering into this covenant with God based on their pledge of full adherence to the Mosaic Law and the sprinkling of the blood of sacrificed young bulls upon them.

Ex 19:7-9

So Moses came and called the elders of the people, and set before them all these words that the LORD had commande d him. All the people answered together and said, "All that the LORD has spoken we will do!" And Moses brought back t he words of the people to the LORD. The LORD said to Moses, "Behold, I will come to you in a thick cloud, so that the p eople may hear when I speak with you and may also believe in you forever." Then Moses told the words of the people to the LORD. NASU

Ex 24:3-8

3 Then Moses came and recounted to the people all the words of the LORD and all the ordinances; and all the people a nswered with one voice and said, " All the words which the LORD has spoken we will do!" 4 Moses wrote down all the words of the LORD. Then he arose early in the morning, and built an altar at the foot of the mountain with twelve pillars for the twelve tribes of Israel. 5 He sent young men of the sons of Israel, and they offered burnt offerings and sacrificed young bulls as peace offerings to the LORD. 6 Moses took half of the blood and put it in basins, and the other half of the blood he sprinkled on the altar. 7 Then he took the book of the covenant and read it in the hearing of the people; and they said, " All that the LORD has spoken we will do, and we will be obedient!" 8 So Moses took the blood and sprinkled it on the people, and said, "Behold the blood of the covenant, which the LORD has made with you in accordance with all these words." NASU

The Mosaic Law was weak and useless in that it perfected no one, but rather, proved to be a source of curses for those under the Mosaic Covenant. Rather than decrease sin, the Law increased sin among the people. Every person under the Mosaic Covenant proved himself to be unrighteous, except our lord Yeshua (Jesus).

To understand more completely God's plan for offering and providing salvation and blessings to All peoples on the earth, it is important to note that there is a limited value of the Mosaic Covenant between God and His chosen people Israel.

"Oh that they had such a Heart in them...Â"

Thus God knew from the beginning, at the very giving of the Mosaic Law, before they had a chance to brak this contract they made with God, that they were incapable of keeping the Mosaic Law.

Deut 5:28-30

28 "The LORD heard the voice of your words when you spoke to me, and the LORD said to me, 'I have heard the voice of the words of this people which they have spoken to you. They have done well in all that they have spoken. Oh that the y had such a heart in them, that they would fear Me and keep all My commandments always, that it may be well with the m and with their sons forever!"

NASU

Indeed, even after they first committed themselves to keeping all the commandments of God, they repeatedly showed w hat little faith they had in God. All the men over twenty years of age would perish over the next 40 years (except Caleb a nd Yeshua who had faith in God and wanted to enter the promised land at the beginng of the Exodus), not being allowed into the promised land due to their disobedience to God's commands and their lack of faith in God.

Once again, after 40 years in the wilderness, Moses addressed all the people of the Mosaic Covenant who were going i nto the Promised Land and reiterated the importance of keeping the Torah, the Law, and advised them that the reward f or keeping this covenant would be great blessings, and he told them specifically what these blessings would be. Deut. 2 8: 1-14.

Moses also informed Israel of the punishment (the curses which would befall them) for breaking the covenant between t hem and God, and he told them specifically what these curses would be. Deut. 28:15-68.

Though the curses included banishment from the land which God gave them and great suffering and persecution in foreign lands, restoration was also promised to Israel at the conclusion of this time of punishment, per Deuteronomy 30.

Then Moses instructed the people about the Covenant that bears his name,

"See, I have set before you this day life and prosperity, death and adversity. ... I call heaven and earth as a witness agai nst you today that I set before you life and death, blessing and the curse. So choose life in order that you may live, you a nd your descendants." Deut. 30: 15 & 19.

In hindsight, we can see that Israel had chosen death and adversity. But this was no surprise to God, for He knew even as Moses was reiterating the Covenant, that His people were incapable of keeping it and would be, in effect, choosing d eath and adversity.

"Then YHWH said to Moses, "Behold, the time for you to die is near, call Yeshua, and present yourselves at the tent of meeting so that I may commission him". ... And YHWH said to Moses, "Behold, you are about to lie down with your fathers; and this people will arise and play the harlot with strange gods of the land, into the midst of which they are going, and will forsake me and break My covenant that I have made with them". Deut. 31:14 & 16.

Even this 'Yshua' was a type of the 'Jesus' who would come to fill all of the Mosaic Law, thereby becoming the perfect P aschal Lamb. God's hint even back in Moses day. For Y'shua was not his real name. his name was Hoshea the son of N un. God assigned the young man the name Joshua (Gr. Jesus) when He assigned the young man to Moses. This Y'shu a was very special, he was the only other man allowed on the mountain when God gave Moses the commandments, Mo ses, was allowed to enter and go from the TENT that God dwelt, Y'shua lived in that tent. Moses, violating the Covenant

of God with man that bears his name, was not allowed to lead the people into the promised, Y'shua was the one who led the peoples into the promised land.

So if the Mosaic Covenant is inadequate to provide Life to God's chosen, and much less so to the other peoples of the w orld, then what is God's plan to bless Israel and the peoples of the earth with life. (Remember, when G-d cast Adam and Eve out of the Garden of Eden, He sent a cherubim and a flaming sword, which turned every direction, to guard the way to the tree of life so that man may not eat of it and live forever).

The answer is given by Moses in Deut. 18:15-19

"YHWH your God will raise up for you a prophet like me from among you, from your countrymen, you shall listen to him. "This is according to all that you asked of YHWH your God in Horeb on the day of the assembly, saying, 'Let me not hear again the voice of YHWH my God, let me not see this great fire anymore, or I will die.' "YHWH said to me, 'They have spoken well. 'I will raise up a prophet from among their countrymen like you, and I will put My words in His mouth, and H e shall speak to them all that I command him. It shall come about that whoever will not listen to My words that He shall speak in My name, I Myself will require it of him. NASU (Caps mine).

Our Messiah, Y'shua of the NT, references this. When accused by the Jews of condemning them, responds 'You search the scriptures because you think hat in them you have eternal life; and it is these that bear witness to me, and you are unwilling to come to me that you may have life. ... Do not think that I will accuse you to the Father; the one who accuses you is Moses, in whom you have set your hope. For if you believed Moses, you would believe in me, for he wrote of me. But if you do not blieve his writings, how will you believe my words.

This prophecy, along with many others to follow, focuses on that male descendant, the seed of Eve, who will crush the s kull of the serpent, who will be a great blessing to Israel and the peoples of the world, the redeemer, the Saviour, the Me ssiah.

Who is this Prophet? That has been the big search throughout history. It is clear that ever since Moses, Israel has sough t and been awaiting this Prophet. In Yeshua's (JesusÂ's) day they asked him, 'Are you the Prophet whose coming is fore told?'

Yet, even in Moses day, God let it be known what the name of that Prophet is via a shadow of what was to come.

Deut 1:37-38 YHWH speaking to Moses:

"Not even you shall enter there . Y'shua (i.e. Joshua) the son of Nun, who stands before you, he shall enter there; encourage him, for he will cause Israel to inherit it.Â" NASU

The above underscores that salvation, redemption, life itself, has not been achieved through the observance and adhere nce to the Mosaic covenant, and seems it was not intended to be, but somehow is directly related to this expected Messi ah.

Ro 5:20

The Law came in so that the transgression would increase; NASU

Gal 3:19-29

19 Why the Law then? It was added because of transgressions, having been ordained through angels by the agency of a mediator, until the seed would come to whom the promise had been made. Now a mediator is not for one party only; w hereas God is only one. Is the Law then contrary to the promises of God? May it never be! For if a law had been given w hich was able to impart life, then righteousness would indeed have been based on law. But the Scripture has shut up ev eryone under sin, so that the promise by faith in Jesus Christ might be given to those who believe.

But before faith came, we were kept in custody under the law, being shut up to the faith, which was later to be revealed. Therefore the Law has become our tutor to lead us to Christ, so that we may be justified by faith. But now that faith has c ome, we are no longer under a tutor. For you are all sons of God through faith in Christ Jesus. For all of you who were b aptized into Christ have clothed yourselves with Christ. There is neither Jew nor Greek, there is neither slave nor free m an, there is neither male nor female; for you are all one in Christ Jesus. And if you belong to Christ, then you are Abraha

m's descendants, heirs according to promise. NASU

We, who are Christians, are no longer under the Mosaic Covenant. We can still agree, as gentiles in Hammurabi's day did also, that things like shaming ones parents, stealing, the taking of an innocent life, coveting, etc., are causes of pain, hourt and suffering. But the keeping of them is not the basis of our redemption, salvation, and righteousness. As it is written in Hebrews, Yeshua is a High Priest, not of the order of Aaron, but of Melchizedek, Where there is a change of Priesth ood, there is also a change of Law. Whereas the Mosaic law was a long list of commandments and statutes that we were required to keep, The laws of Christ keep us and accounts to us righteousness.

Heb 7:11-22

Now if perfection was through the Levitical priesthood (for on the basis of it the people received the Law), what further n eed was there for another priest to arise according to the order of Melchizedek, and not be designated according to the order of Aaron? For when the priesthood is changed, of necessity there takes place a change of law also. For the one co ncerning whom these things are spoken belongs to another tribe, from which no one has officiated at the altar. For it is e vident that our Lord was descended from Judah, a tribe with reference to which Moses spoke nothing concerning priests. And this is clearer still, if another priest arises according to the likeness of Melchizedek, who has become such not on the basis of a law of physical requirement, but according to the power of an indestructible life. For it is attested of Him,

"YOU ARE A PRIEST FOREVER ACCORDING TO THE ORDER OF MELCHIZEDEK."

For, on the one hand, there is a setting aside of a former commandment because of its weakness and uselessness (for the Law made nothing perfect), and on the other hand there is a bringing in of a better hope, through which we draw near to God. And inasmuch as it was not without an oath (for they indeed became priests without an oath, but He with an oath through the One who said to Him,

"THE LORD HAS SWORN AND WILL NOT CHANGE HIS MIND, 'YOU ARE A PRIEST FOREVER'");

so much the more also Jesus has become the guarantee of a better covenant. NASU
