I suppose I should have posed the question more clearly; I was meaning to ask about Christians owning a firearm which is not suitable nor intended for sport or hunting.

Concerning your reference to Romans 13:3,4:

My own opinion is that the all-encompassing command is: "We must obey God rather than men!", (Acts 5:29). Earthly governance is formed by what Paul named as 'elemental spirits'. As such, they are weak and beggarly and prone to "repay evil with evil"; also, simultaneously reaping what they sow.

So, for the sake of this discussion, let's lay out the underlying parameters:

While we are citizens of a heavenly kingdom, we also live in the natural world. Therefore, the disciple of Jesus is also a good citizen of the emperor, an orderly citizen of his town, a punctual taxpayer and respectful towards the representatives of the government and of the authority. This is why the early Christians were not rebels against the state. They submitted to the government; despite the fact that oftentimes their leaders invited disgust and contempt.

We know that in the Kingdom of God there are both principalities and powers. This confirms that not all spirits in the unseen world are equal. In addition, there are throne angels, cherubs, governments, angel of the church, messengers, and there is also the angel of the Lord. Further, there are also tens of thousands of angels who stand under their own princes.

The devils also know a similar hierarchy. They have their principalities, powers, rulers and their legions of evil spirits too which are subject to their leaders.

The human spirit too belongs to God's hierarchical order. Mankind shares a hierarchy; king and subject, state government and federal government, parent and child, master and servant, employer and employee. The hierarchical formation of human spirits are what constitute our social and political order.

It is this hierarchical order which makes known the reigning "elements of the world" which cause life to be possible on earth. While all these hierarchical power relationships are God ordained, this doesn't mean to say that the authorities are directly appointed by God.

So it is that we are living in a world which is ruled by innate hierarchical laws. As a side thought: this same hierarchy role and structure can also be found in the animal world. In the animal world too we find leadership roles and relations between creature parents and the obedience of their offspring.

Therefore, we also see how the Law of Sinai made ​​use of some sort ordering and structure and therefore it too is directly associated with the "elements of the world", (Gal 4:3.9 and Col 2:8 & 20).

The Bible describes these "elements of the world", (or, "elementary spirits"), as being weak and beggarly because they are human spirits which are without the power of the Holy Spirit and therefore unable to oppose the lawless forces originating from the kingdom of darkness.

So, it is that these weak and beggarly spirits can only resist and maintain their authority by natural remedies and penalties; unable to overcome the powers of evil, they are left with no alternative but to exterminate its manifestation.

Without observing the social and political relationships, life on earth would be impossible; everything would soon tumble into a chaotic and undisciplined mob. Not surprisingly, anarchy is said to be a special sign of the end times.

The Apostle Paul fully knew that the Christian is no longer subject to "the law". Rather, the Christian is free and no longer a slave, a king and a priest, an heir of God and joint-heir with Christ.

However, he also knew that in the natural world the Christian remained subject to the requirements of the 'elementary spirits'. A slave was to remain obedient to his master, (both the good and the bad), a child to his parents, (both the believer and unbeliever), and also the citizen must remain obedient to an often unreasonable and immoral government.

So, member 'RobertW', the Scriptures about submission to authority which you referenced are (needless to be said by

me) clear and straightforward truth.

It was a lying, false accusation, when the Jews accused Jesus before Pilate against Caesar, saying that He forbade to give tribute to Caesar, (John 19:12, and Luke 23:2). Our Lord Himself paid both the Synagogue taxes and secular government taxes, (Matt 17:24-27). He also subjected Himself to the world spirits during His natural life. He remained submissive to the hierarchical order; example: subservient to his parents, recognizing that Pilate had power over Him, (having received such power from above), (John 19:11).

An incompetent and unwise government is still better than no government. For times of bad government, the Lord says, "Be not afraid of those who kill the body but can not kill the soul", (Matt 10:28). It's not for nothing that the Bible says, "I exhort first of all supplications, prayers, intercession and thanksgiving be made ​​for all men, for kings and all in authority, that we may lead quiet and peaceable life in all godliness and dignity", (1Tim 2:1,2).

Anyways 'RobertW', I said all the above to clearly state that I don't wish to be found twisting the Word "to their own destruction, (2Pet 3:16).

The word "sword" in your referenced Scripture illustrates the avenging justice on this earth; a justice which repays evil with punishment. The government bears the sword and she is the only person in the social hierarchical order on earth that has consent to punish. They repay evil with evil, and therefore speak the language of workers of wrath.

We are entering into a time when the following is being fulfilled: "And I will give children their princes, and babes shall ru le over them. And the people shall be oppressed, every one by another, and every one by his neighbour: the child shall behave himself proudly against the ancient, and the base against the honourable", (Isaiah 3:4,5). Therefore it is becomin g increasingly necessary to submit, not only because of fearing the workers of wrath, but also for conscience sake.

Many think a government is owed ​​their obedience only if it matches their views and their interests. This is not scriptural. A Christian, who is truly a spiritual man, will for the sake of his conscience not engage in disorderly con duct. Both Paul and Peter lived at a time of a very tyrannical regime and yet lived victoriously. They did not speak criticis m against their governments because they didn't consider this as their task. Instead, they had a positive posture about the governing authorities and obeyed. They prayed about their governments, for their good, if there was any, as well as for their evil.

That is one of several possible interpretations. Throughout church history it is one that some have advanced. There are p robably a half dozen various interpretations that have gained traction at one time or another in the history of the church. However, it is just one and it requires a fair amount of pure supposition to come to that conclusion. However, it is one way to view it. There certainly is nothing in the text to strongly make that the proper understanding.

One of the weaknesses of your interpretation is that you must remove Jesus words for them to "get or buy a sword" from the entire context and statement it came in. That normally will get into very faulty interpretation.

Recall that Jesus not only told them to now "get, or buy a sword" but to also to take a purse (to hold money) and a bag (t hat held possessions). If your thoughts are correct then where is the use of those at Gathsemane. Jesus clearly made them part of the same instructions as the sword.

A second complication of your interpretation is this - Jesus Himself said he was referring to the times of when they went out in ministry for taking the sword, purse, and bag. Note in Luke 22:35 he specifically references those times, " Then Je sus asked them, Â"When I sent you without purse, bag or sandals, did you lack anything?Â" Â"Nothing,Â" they answere d".

His words about the bag, sword, purse are then immediately given as to what they are to now take as opposed to when He instructed them to take nothing with them. It would seem fairly obvious that the clearer meaning is that they were sen tout initially with noting so as to have to trust God for daily provision. Once that was experienced they could take provision having learned not to depend on those... but on God. Much as Paul saying that he had been in abundance and in want but regardless he was content in fulfilling the plan of God.

Let's also take a practical real world example. I am assuming you are a male but forgive me if not. No way to tell from an internet name. So.. I am making that assumption.

What if you came home to find your wife beaten and tied to a kitchen chair with duct tape. Your two teenage daughters a lso beaten, bound feet and hands and laying on the floor. Two men are in your house that did this. They are eating the s upper on the table prepared by your family. You see the situation through the door window but they did not spot you. Ho wever, you do hear them tell your wife and daughters that they are going to rape them after they eat and then slit their th roats. They are going to make your wife watch your daughters be raped and killed before they do the same to her. Thes e men have no guns. They were just bigger and stronger. HOWEVER, you have a shotgun and pistol in your workshop in the back. You can get one of those firearms and save your your wife and daughters from rape and murder... or you can let it happen... or you can call the police who will make out a nice report when they come to work the murder scene in a couple of hours. Bottom line...you step in and make a move to save your wife and daughters from rape and murder now or it will happen starting in 2 minutes.

You now have 120 seconds before it begins.... what do you do?

When it comes to gun ownership, I do not own one. I do know hunters who hunt for food and are quite successful at it. My grandfather had a farm. When we visited him, he would often serve us food that he has shot and killed (either from h unts or from his farm). I remember that my aunt once told me that it had been years since they had purchased food at the grocery store.

Since I purchase my meat at restaurants and the grocery store, I don't feel a need to own a rifle.

I also know members of the police who own weapons. Those weapons are not used to "murder" individuals, but to keep the peace and prevent violent men from carrying out violent acts. Military men sometimes carry a gun too. As brother R obert shared, this is a scriptural precept. In addition, the New Testament speaks of secular authorities who are instrume nts of punishment for evildoers. In fact, Paul, when standing before King Festus, mentioned that he would not refuse to die if he had broken the secular law in a way that carried the death penalty (Acts 25:11).

As for the American nation: The Declaration of Independence makes it clear the intent of the founders of the nation in 17 76. They believed that certain anecdotal actions demonstrated that it was necessary to dissolve the political bonds betw een the colonies and the nation from which they had once been tied (England). The colonists believed that they had, by virtue of self-governance and the lack of proper representation in England, achieved a "separate and equal station to whi ch the Laws of Nature and nature's God entitle them."

Thus, the colonists didn't see their independence as "rebellion" but as defending their "independence" and solidifying the separation from former bonds on the basis of the state of the colonies at the time and the ideas that were not shared with England and its rulers. In fact, most colonists declared the subsequent "war" that existed between the United States and England as the "War of Independence" rather than a "Revolutionary War."

In the Declaration and subsequent state documents (the governments of the states remained the same before, during a nd immediately after the war), the colonists and their leaders were adamant that the states were "separate and equal" st ations. Thus, they held an army to protect and preserve that status.

The gun violence in this country is troubling. However, when just the size of the population and the number of shootings per 100,000 is compared, the rate of shootings/deaths in the US is similar to many other nations. And, when you consid er the availability of guns in this country and compare it with other nations with similar availability (guns per 100,000), the rate of shootings in the United States is actually relatively low-to-average. It is still too high...and I think that steps can be taken to lower it even further.

I don't mean for this thread to get sidetracked by this, but I simply wanted to touch on something from a previous post.

Like Robert and others have said, there are legitimate reasons to own a gun (like hunting), so I would answer the origina I poster that it is acceptable for a Christian to own one. However, I agree with DEADn about the need to safeguard and understand it.

I think that you jumped to conclusions here.

First of all, I am not taking the side of what you conclude to be the "rebels" from 238 years ago. I am simply stating what they believed about themselves. They didn't see the Declaration of Independence as an act of "rebellion" against their o wn king. Rather, they explained it via the quote from the Declaration that I quoted earlier.

The founders stated in many writings that they were already self-governed through their own elected and appointed stat e authorities and had been for years. They stated their case that theirs was a government of consent...and that only political ties were binding the states with England. The founders argued that those political ties had become destructive in regard to consent and liberty and that, as self-governed states, had a right to "alter or abolish" those former ties.

Now, this is not from the "hands of men's perceptions" any more than those who paint a different picture of history. I am simply stating the views of the founders. Consequently, I strongly reject any insistence that I wrote this to "justify" my "a ctions of today."

Personally, I view my American citizenship as being immeasurable distant behind my Heavenly citizenship. The reign of kings, kingdoms, nations and even the opinions of men are fleeting in terms of expanse of Eternity.

Kings and kingdoms rise and fall. The oldest existing hereditary monarchy can only claim to trace itself for a couple of th ousand years. Even the reigns of the "mighty" kings and empires eventually came to an end when others arose to take t heir place (or to simply reject the authority of the old order). I view the American nation as yet another nation that God o rdained (Romans 13). In this case, it wasn't another kingdom that conquered an existing world power, but a government of consent.

In the sense of "liberty" or "rights" to bear arms, I stated that I have no reason to do so. I don't hunt because I buy my m eat at supermarkets and restaurants. However, in answering the question posed in the first post, there are individuals w ho do so and I see nothing wrong with that.

Now, there is a legitimate debate regarding whether or not guns can be used for purposes other than hunting. I underst and the views of some "non-resistance" brethren who view this as a conflict with the faith. Yet, I gave my thoughts earlie r and I will simply leave it at that. I don't think that anyone here -- myself included -- should prop themselves up at the en d-all authority of the matter. God's Word is the only truth on this matter...and there are obviously varying opinions on wh at the Word does or does not say on the matter.

Like you, I praise God for the true freedom that He has given me and the grace that I experience through Him. It transce nds the temporary governments of man and provides the peace that passes all understanding to those whose hearts are resting in Him. Even if I was under the threat of death, imprisonment or torture from a hostile power, I understand that to live is Christ and to die is gain! I am prepared to live or die for the cause of Christ with His peace in my heart.

At the same time, I am glad to live in a nation that is still relatively free. There is a lot of responsibility in this. Americans and other free (or relatively free) nations have been given a valuable talent.

Today, a missionary spoke to our local congregation about the things that he has faced. I can't help but compare the lib erty that we know here in America with the difficulties that he faces overseas. Yet, I also can't help but wonder if we hav e been a good investment. What have we done with the talents that God has given us? Are we burying them under the

sands of religious discussions, arguments and/or assertions with other believers? Or, are we making the most of the opportunities for which we have been provided?

May the Lord help us to do what we can with what we have to bring about the increase that the Lord will provide!

I remember in boot camp where I was assigned to a school to learn to be a medic. I was with a group of men like myself who had been conscripted for the war effort in Vietnam. My other choices would have been to run from the country or le arn to be a killer. The conscious objector route seemed to be the most practical, though I wanted none of it.

Knowing what loomed over all our heads, the conversations in the barracks were pretty intense as we all pondered and j ustified our Christian obligations against the military duties we were under. Mike D'Angelo swore he would not ever use a weapon... But when his unit was pinned down and getting overrun with Vietcong, many of the other men dead or woun ded, he did what he had to do, saving the life of his wounded Captain.

It's different when you're there, suddenly the guns are blasting, people are screaming, bodies crumpling, and all the disc ussions and philosophying are lost. You fight, you kill fast because more are coming, your head goes empty and your m outh is so dry you couldn't utter a prayer if you wanted to.

Funny how in Jesus' teaching, He used the illustration of the King going out to battle and considering how many troops he would need to accomplish a victory. He knew all about this stuff, and spoke the narrative of human conflict. The hum an story has always been one of war, and it's not over yet. And when Jesus spoke to the Roman soldiers He told them only to be content with their wages. He who created the world did not use power to halt human killing.

I grew up in the idyllic American fifties. Lived in the country, had a dad who loved my Mom, became a Christian early in I ife. I went off to war under the yoke of stupid political realities, a timid little kid scared to death. I came back an experien ced soldier, with images in my mind and heart that will never leave.

Yet it was good, because of the grace I received to know and love God with all my heart. I saw how He took what I coul d in no way appreciate and used it to implant His Son in my soul.

I have heard Him utter words to me in my heart I have no right to hear-

"You are My son, whom I love, and with whom I am well pleased!"
