Claiming that "same-gender couples are as capable of responsible procreation as are opposite-gender couples," the N. M. Supreme Court found on Thursday that gay marriage is legal under the New Mexico Constitution.

"We hold that the State of New Mexico is constitutionally required to allow same-gender couples to marry and must exte nd to them the rights, protections, and responsibilities that derive from civil marriage under New Mexico law," Justice Ed ward L. Chavez wrote for the N.M. Supreme Court.
