# If You Own a Mortgage, Read This!, on: 2014/3/1 12:19

First you must know that the federal government took America off the gold standard in1933, during a staged bankruptcy called the "Great Depression― and replaced the gold with an economic principle known as "Negotiable Debt Instruments." The government needed to create a catastrophe to implement standards that were designed to steal your possessions and God-given rights. The process of creating a catastrophe was discovered by behaviorists. Take away a person's food, comfort and safety long enough and they won't care or question the illusion provided, as long as their stomach is full, they have shelter, a comfortable bed and the means (real or imagined) to keep or continue their co mfort. President Roosevelt unconstitutionally collected America's gold by Executive Order and sold it to the Vatican by way of China to conceal its true ownership. The gold in Fort Knox belongs to the Vatican and not the United States. A bsent a gold base, Commerce now essentially trades in "debts.†So if you borrowed money for a mortgage and th ere's no gold or real value to support the paper called U. S. Currency, what did you actually borrow? Factually, you borrowed debt. The mortgage company committed the ultimate fraud against you because they loaned you nothing to pa y off the imaginary balance, not even their own debt instruments. They then told you that you owe them the unpaid balan ce of your home and that you must pay them back, with interest, in monthly installments.

Here's how they did it. At your closing, the mortgage company had you sign a "Promissory Note†in which you promised your sweat, your equity, full faith and credit against an unpaid balance. Then without your knowledge, the mort gage company sold your Promissory Note (your credit) to a warehousing institution such as Fannie Mae or Freddie Mac. The warehousing institution uses your Promissory Note (your credit) as collateral and generates loans to other people a nd corporations, with interest. Collateral is essential to a corporation because corporations have no money or credit. The y're not real, they're a fiction and require the sweat, the equity, the full faith and credit of living individuals to bre athe and sustain the life of the corporation. Corporate Governments operate under the same principle. The warehousing institution makes money off the "Promissory Note†(your credit) and even though the profits made are nothing mor e than new Negotiable Debt Instruments, those instruments still have buying power in a Negotiable Debt Economy. Thes e debt instruments are only negotiable because of the human ignorance of the American people and the human ignoran ce of people in other countries of the world, who have all been lied to, told this has value, and the people don't know the difference. Did you ever give your permission to the mortgage company to sell your credit? So where is your cut of th e profits? If the mortgage company invested nothing of their own in the purchase of your home, why are you making a m onthly mortgage payments to them with interest? And where do they get off foreclosing on or against anyone or threaten ing to foreclose? They do it by fraud and the Masters and their Agents (the governments, the courts and the banks) all k now it! Everything done to us and against us is about sustaining their lives, the lives of the corporate governments they c ommand and to keep "We the People†under their complete control. They accomplish this control by taking away or threatening to take away your comfort and independence. They all use fraudulent means, disguised as law.

Note: When you applied for a mortgage, the mortgage company ran a credit check on you and if you had a blemish on y our credit record, they charged you points (money) to ease their pain and lighten the risk (a credit risk) of their loaning yo u a mortgage. More Fraud! Why are you paying points, when they never loaned you a dime? The credit report is just ano ther scam. If you have a high credit report, the government and banks identify you as an "Obedient Slave†and yet your "Promissory Note†sold for the same value as the "Promissory Note†endorsed by the man who is " a credit risk.†Credit didn't matter. The fact that you are a living person is what matters!

More Fraud: The mortgage company maintains two sets of books regarding your mortgage payments. The local set of b ooks is a record that they loaned you money and that you agreed to repay that money, with interest, each month. The se cond set of books is maintained in another State office, usually a bank because the mortgage companies usually sell yo ur loan contract to a bank and agree to monitor the monthly payments in order to conceal the fraud. In the second set of books, your monthly mortgage payment is recorded by the bank as a savings deposit because there is no real loan. Wh

en you pay off the fraudulent mortgage, the bank waits 90 days and then submits a request to the IRS. The request stat es that: "Someone, unknown to this facility, deposited this money into our facility and has abandoned it. May we kee p the deposit?†The IRS always gives their permission to the bank to keep the deposit and your hard-earned money ju st feathered the nest of the Rockefellers, Rothschilds and eleven other wealthy families in the world!

Equity Law, which once controlled America's Corporate Courts, has been replaced with Admiralty/Maritime Law, pur suant to Title 28 of the United States Code and the Judiciary Act of 1789. This is the Law of Merchants and Sailors. Und er Admiralty/Maritime Law, the courts presume you owe the mortgage or the tax or that you committed a crime defined a s a Criminal Statute and it is your obligation to prove you're innocent! This means, you're guilty until you prove y ou're innocent, which is the same standard and procedure used in a Military Court Martial. Haven't we always b een told that "You are innocent until proven guilty?†Lies, Lies and more Lies! We are not free men; we are slaves, and bound to our Masters by adhesion contracts and secret Trusts. The goal of the Masters and their agents, our electe d officials, is to keep the people oppressed and subservient to them. As the Masters' agents, they utilize propagand a techniques through government-controlled schools, churches, the media and mind control by force and or the threat of force through the courts and police enforcement. The more regulations, statutes and codes created, and the greater the number of regulatory officers and agencies created to enforce them, the greater the Masters' control over their slaves; and that is mind control by force and threat of force, by the very people we rely on, to protect and serve! - 1. The Federal Reserve Bank is a private banking system created by foreign interests. Call any branch for verification.
- 2. The Federal Reserve Bank is the sole creditor of the United States and the entire national debt is owed to the Federal Reserve Bank. Write your congressman for verification.
- 3. There are twelve member banks in this system and according to their bylaws (articles of association) they each have t he power to act as depositary and fiscal agent (tax collector) of the United States.
- 4. Federal Reserve Board regulations and Generally Accepted Accounting Principles prohibit member banks within the F ederal Reserve System from lending money from their own assets or from other depositors. Federal Reserve member b anks do not make loans.
- 5. Bank customers fund their own mortgage transactions by signing a note. The note is the creation of currency that nev er existed before being signed by the customer.
- 6. Because the banks have monopolized the market on negotiable instruments, only banks will accept your promissory note. You can't buy groceries with a promissory note for example.
- 7. The practice of failing to disclose these facts in the mortgage agreement voids and nullifies the note because it violate s 12 CFR 226.17(c)(1) of the Truth in Lending Law.
- 8. Unsecured debts assigned to debt collectors are not legally enforceable without the consent of the customer.
- 9. The banks must pay their customers back the entire value of each note and credit limit minus fees and interest.
- 10. These facts apply to both secured (e.g. mortgages, credit cards) and unsecured (e.g. credit card) accounts.
- 11. There are no disclosure or application requirements for a social security number. There are no penalties for refusing to disclose a social security number to anyone. 26 CFR 301.6109-1(c). This is a ruse perpetrated by the FDIC, Federal Reserve and insurance industry for the purpose of illegally monitoring American citizens.
- 12. The credit reporting system is the creation of the Federal Trade Commission. Its primary use is to collect and build in

formation databases about Americans. It also provides an inexpensive means for banks to unfairly punish people and de stroy reputations by subverting the legal requirements normally imposed upon them under the court system.

#### Submission to Governing Authorities

13 Let everyone be subject to the governing authorities, for there is no authority except that which God has established. The authorities that exist have been established by God. 2 Consequently, whoever rebels against the authority is rebelling against what God has instituted, and those who do so will bring judgment on themselves. 3 For rulers hold no terror for those who do right, but for those who do wrong. Do you want to be free from fear of the one in authority? Then do what is right and you will be commended. 4 For the one in authority is God's servant for your good. But if you do wrong, be afraid, for rulers do not bear the sword for no reason. They are God's servants, agents of wrath to bring punish ment on the wrongdoer. 5 Therefore, it is necessary to submit to the authorities, not only because of possible punishment but also as a matter of conscience.

My husband had ordered checks from a company in CO. They shipped them by FedEx and were stolen by an employee in Memphis who proceeded to write checks all over town. An alert employee at our bank caught it and they were returne d to the cashing banks. We got affidavits from the bank, local police department attesting to our declaration that this was stolen property. We closed this account at the bank, opened another. Anyhow, what do you think this did to our credit re cord? My husband, bless his heart, could not write checks for a while in the city thirty miles north even though I could - a nd the forged checks were signed using my name.

Then there are companies who work to collect money on bounced checks and they get nasty - even after sending copie s of the affidavits. They will still red flag your credit report.

The bright light in this experience was an alert bookkeeper at our bank who spotted this forgery thus preventing any mon ies being withdrawn from our account. But the check cashing/collecting companies were not so kind.

Yes, every time I read an article like this, being ignorant of a lot of the ways and means in the banking world, I just think one is better off using cash and living debt free as much as possible - keeping it simple.

- 4 For he is the minister of God to thee for good. But if thou do that which is evil, be afraid; for he beareth not the sword in vain: for he is the minister of God, a revenger to execute wrath upon him that doeth evil.

But in our Constitution we have the right to move about freely and travel unencumbered. They cannot turn a liberty into a crime but they are trying to. Now, if you are a travell er on the roads you don't need a driver's license, but if you are operating on the roads as a commercial concern then the

DMV defines you as a Driver and not a traveller.

When you register anything with a U.S. governmental body, you are transferring ownership of that possession to them.

When you register your car with the DMV you are giving ownership over to them.

In California, a license is defined as "A permit, granted by an appropriate governmental body, generally for a considera tion, to a person or firm, or corporation to pursue some occupation or to carry on some business subject to regulation un der the police power."

Rosenblatt v. California, 158 P2d 199, 300.

If ever a judge understood the public's right to use the public roads, it was Justice Tolman of the Supreme Court of the S tate of Washington. Justice Tolman stated:

"Complete freedom of the highways is so old and well established a blessing that we have forgotten the days of the Rob ber Barons and toll roads, and yet, under an act like this, arbitrarily administered, the highways may be completely mono polized, if, through lack of interest, the people submit, then they may look to see the most sacred of their liberties taken f rom them one by one, by more or less rapid encroachment." Robertson vs. Department of Public Works, 180 Wash 133, 147.

"The Right of the Citizen to travel upon the public highways and to transport his property thereon, either by horse drawn carriage or by automobile, is not a mere privilege which a city can prohibit or permit at will, but a common Right which he has under the right to life, liberty, and the pursuit of happiness." Thompson vs. Smith, 154 SE 579.

Here the court held that a Citizen has the Right to travel upon the public highways, but that he did not have the right to c onduct business upon the highways. On this point of law all authorities are unanimous.

"Heretofore the court has held, and we think correctly, that while a Citizen has the Right to travel upon the public highways and to transport his property thereon, that Right does not extend to the use of the highways, either in whole or in part, as a place of business for private gain." Barney vs. Board of Railroad Commissioners, 17 P.2d 82; Willis vs. Buck, 263 P. I 982.

"The right of the citizen to travel upon the highway and to transport his property thereon, in the ordinary course of life and business, differs radically and obviously from that of one who makes the highway his place of business for private gain in the running of a stagecoach or omnibus." State vs. City of Spokane, 186 P. 864.

So what is a privilege to use the roads? By now it should be apparent even to the "learned" that an attempt to use the road as a place of business is a privilege. The distinction must be drawn between... Travelling upon and transporting one's property upon the public roads, which is our Right; and Using the public roads as a place of business or a main instrume ntality of business, which is a privilege.

Other U.S. court cases that confirm and point out the difference between the "right" of the citizen to travel and a govern ment "privilege" are - Barney v Board of Railroad Commissioners; State v City of Spokane, 186 P. 864; Ex Parte Dickey (Dickey v Davis), 85 S.E. 781; Teche Lines v Danforth, 12 So.2d 784. In Marbury v. Madison, 5 US 137 (1803) it is state d that The Constitution of these United States is the supreme law of the land. Any law that is repugnant to the Constitution of America is null and void.

Murdock v. Penn., 319 US 105 (19) "No State shall convert a liberty into a privilege, license it, and attach a fee to it." Sh uttlesworth v. Birmingham, 373 US 262 (1963) "If the State converts a liberty into a privilege, the Citizen can engage in the right with impunity." Miller v. U.S., 230 F. 2nd. 486, 489 (5th Cir. 1959) Id. at 489-490
