"In interrogation, once they beat me very badly,― Saeed Abedini told Fox's Greta Van Susteren on Monday, "because they wanted me to write something, which I didn't do that.―

"It actually was in a courtroom where the judge closed the door and the interrogators started beating me, which in th at time, I had stomach bleeding,†he said.

"They beat you with their fist?†Van Susteren asked. ...

Naghmeh Abedini on Facebook apologized to her followers for not disclosing the abuse sooner.

"I sincerely had hoped that this horrible situation Saeed has had to go through would bring about the spiritual change ne eded in both of us to bring healing to our marriage," she said. "Tragically, the opposite has occurred."

In an interview at her parent's home in Boise last week, Naghmeh Abedini had told Reuters that rebuilding their mar riage after her husband's imprisonment would take time.""

She even alludes to rebuilding the marriage, although she makes the point that she is tired of being an "enabler".

This whole thing reminds me of Tom White and Voice of the Martyrs which to this day is so tragic.

Brother Franklin has said that many of the things being reported by the media are not true regarding Saeed. He has spoken into the lives of both Saeed and Nagmeh. He has been one instrumental and praying in bringing about the r elease of our brother Saeed. I have no doubt that Franklin Graham has far more understanding in this situation than we in this forum do. Is this forum prepared to challenge the credibility of Franklin Graham?

I remind this forum again Brother Saeed has suffered for his faith in Christ. Who in this forum has spent 3 1/2 years in sn Iranian prison hell hole undergoing the tortures that Saeed did?

From the things I have read in the sources I use to track the persecuted church. Saeed was beaten to within an inch of his life. Those who torture are taught to beat prisoners to where they lose consciousness. Then the prisoner is revived a nd beaten sgain. These constant beatings have resulted in internal injuries where Saeed may require surgery. Saeed w as also tasered. This result being pain in his heart.

In addition to the physical tortures there are the psychological and spiritual tortures. The brother was required to watch S unni Muslims being hung for their faith. Iran is Shia Muslim. Thus they have a hatred for Sunni Muslims. So the prison ers would be paraded out to the courtyard. There they were forced to watch the hanging of political and religious prisone rs. Those who were abiut yo be hung would cry. Many would wet themselves I can only imagine the scars that this will I eave on our brother.

Also there was a constant danger of ISIS threats against his life while in prison. Plus the fact that he was beaten by othe r prisoners.

It was recorded to his parents that he woke up one morning with a knife at his throat. The person who had the knife at his throat wanted to steal his toiletries.

Add to this fact the Iranian authorities consistently tried to get him to deny his faith in Christ. The psychological and spiri tual torture that came from this one can only imagine.

I share this. Because I wonder in the hell that Saeed went through. How? And I asked how? Can one say that his mind was set on pornography? It would seem the brother would be more concerned trying to stay alive. And keep his faith constant in Christ.

Perhaps in American prisons access to pornography is available. But in the worst prison in Iran where Saeed was imprisoned. I have to wonder how the brother could have access to pornography???

Also the verses in 1st Peter 4:1 tell us that he who has suffered in the flesh has ceased from sin. Is anybody in this forum prepared to say the Saeed has not suffered in the flesh?

Let's stick to facts everyone:

Go to YouTube & you can see a recent CBN interview with Nagmeh. She didn't intend to "make his sins public". She sha red in confidence with "a close friend" who then shared this elsewhere & made it public. She is now dealing with it. It does appear that she has made public statements that he was abusive with her at times, has struggled with pornography, & is yet seemingly unrepentant (she said she wanted to reconcile & heal, but filed for legal separation just after his reuniting to the family, which certainly seems to indicate either he isn't truly repentant, humble & willing to work through these is sues with counseling, or she has bitterness/unforgiveness inside because of it, or most likely some variable combination of both).

While I too have prayed for the brother too & hoped desperately for his release & rejoice in it, & I AM CERTAINLY NOT "ATTACKING HIM", the truth (laid out in scripture) is still true: "if I give my body to be burned, but have not love, it profits me nothing." I used to preach & evangelize everywhere I went. I stood on street corners all night every weekend pleadin g with the lost to come to Christ & live. I was only threatened to be beat up a few times because of it, but if I would have arrested & beaten for it, I still wouldn't have denied Christ!

However, at the same time back in those days, although I have never laid a hand on my wife (or any woman) & she was far from perfect, I was not truly loving her in every way the way Christ commands husbands to do. So did my service null ify 1 Corinthians 13, Ephesians 5 & so much of the rest of scripture? By no means. And while I am in no way "casting sto nes", the fact still remains that Saaed needs to repent (unless Nagmeh made all this up, which I highly doubt, especially if he has gone to court over it), that she needs to be willing to forgive, they need to heal, but that will hingent on Saeed's willingness to humble himself, repent, & work through this honoring his wife & forgetting about his public image.

And I'm going off of words straight out of Nagmeh's mouth which she would gain nothing positive by strong publicly (but shame/embarrassment). So yes, even if he was persecuted & beaten & stood strong & didn't deny Christ, but IF (& that's a big if because we don't know everything & need to be careful what we assume) he now refuses to humble himself & repent to his wife, he is not to be treated "exempt" from the whole of scripture on the matter. So I'm neither "exalting/exhonerating" him if he doesn't love his wife as Christ loved the church, nor "attacking/accusing/maligning" him if he is repent ant. He is held to No higher or lower standard than any other brother in the world. And I LOVE & consider, pray for & support & promote the persecuted church worldwide often & regularly, but that's not a rubber stamp on every area of ones we alk/life. Ghandi was beaten, maligned & absurd for his Buddhism & beliefs. But that didn't make him right with God.
