Here is some of my family testimony...

This was for about over 4 years, and near dying in all the squalor of his life and God saved him.

He is going to Romania in the Autumn with the Christian fellowship he has been living and working with for the past six y ears. God saved his life and blessed him with faith.

And my other brother came through dramatically in my church the very moment we began to sing. (He had come back to the UK after his travels).

He said I was only popping in with you and wham!!

Six years later, he has met a Christian girl, he is 38 she is 34 and they are going to marry. Oh boy! Are they both in tune with what God would have for them and I know God is going to use them.

My Dad died at 54 one brother died at 30 by suicide and another brother died at 45 with heart problems. I have an older brother who has bipolar my Mother is 78 and goes to see him and spend time with him even when he is having big probl ems with the voices and his changing attitudes. But in him there is a heart of Gold.

I have two sons and a daughter in their late 20Å's they all know Jesus but non-practice the Faith. Much prayer is continu ally prayed for them and there have been some scary moments that have needed prayer

Try not to worry about your young son he does not perceive the world as we do.

We have experienced many things in our lives.

I learned that, time, as months and years is long to us. In Gods time, it is but a flash. And because we are human time s eems so long.

He so requires us to pray to keep the light shining on him and his friends, this actually gives you more young people to p ray for and there will always be new ones turning up in his life. (When you get into the praying for his friends, also you wi Il begin to feel the privilege bringing other sons and daughters before the throne of God).

Even when your son does not see the light of the Lord. Just love him, be happy with him encourage him, when you can. Don't frown at him it hurts. God will teach you so much because you are his. He knows your concerns, talk with him he is your Heavenly Father.

He went to a Christian school, many (most) staff members are Christians and many of his peer group from Christian families, (some of them with a personal faith), although the school was open to all faiths and none, according to a selective process. Many of these peers are at university now, but he is unsure what to study, yet, and is working usefully with a global company, (with excellent career prospects) well-suited to his natural intelligence and skill base. His job means a lot to him because it confers financial independence. I don't think he'll deliberately jeopardise it, but, it is not clear to me what the Lord has in store, either of work or study. For now, it is a tremendous blessing that he has a job which he wants to turn up for every day.

You're right that he is influenced by his peers. ellie has pointed out I should be praying for them too - which had not crossed my mind, I'll admit, but - which makes good spiritual sense.

When his university friends come back at holidays, a group of them get together and perform at a local club. They all studied music to school leaving standard and it is beautiful to see the trust they have of each other's musical abilities. In many ways, these guys are brothers to him, more than any others and although they don't keep in touch much during term time, I know it is good for him that they want to include him and even though it pressurises his time more than he would wish, the validation they give him is an important part of his social development.

Knowing how difficult he finds form-filling is one possible explanation. I'd say too, it's more likely he has been a witness, than the culprit in an event, but, since he is doing weed (because he can since HMG altered the regulations last year - just at a time when the strength is much more than previously! :-() I cannot be sure it's not drug related.

He has a strong sense of what is right and wrong when it comes to others' (friends') best interests, but is unlikely to have *committed* any violence, himself, as he hates that too.

I would ask we pray for him to 'do' anything he's supposed to 'do' before he has tried the system's patience too long, and

, that he does not compromise his own reputation for honesty.

Today, there was another phone message from the police, so I texted my son who was still at work and said: Either ans wer the police or tell me why they're ringing here.

I thought you'd get a flavour of our relationship if I quote from his replies, which are also very reassuring.

1. 'Im not in trouble you paranoid muppet. im a witness in a common assault case. If they call me from non-withheld nu mber, I can call them back.'

(In the UK, all official organisations bar their number from outgoing calls.)

2. 'If they call again give them my number and tell them to leave a g\*\*\*amn message. I'll try them tomorrow but I'm wor king so my phone is off. If they can't figure out how to leave a message they shouldn't be cops.'

In answer to my question of why they are ringing my home and not his, he said - 'cos the incident happened before he m oved.

Thus, my anxieties have been allayed, and the event has been a good point of contact between him and me. And I will try to find out if he really is going to give evidence in Court, so we can pray for him when he does. :-?

Doesn't God move in mysterious ways, His wonders to perform? :-P

While I was away recently, my son looked after my rabbit. When I went to pick her up, I learned that one of his housemates, an American who looks 40 to me, but claims to be 25, lost his cool sufficiently one evening, (under the influence of alcohol) to partially wreck the house in a controlled attack of rage... by which I mean, he does/did not attack people for the most part, but does/did serious damage to things - door off hinges, radiator bent off the wall to name but two. The housemates have had to report the incident to the police, and are waiting to know what will transpire.

My son and two of them are looking for new accommodation. There are two others who seem to be 'siding' with the man who 'lost it'.... I understand he came to the UK to get his life back after serious addiction and drug dealing. For the most part, he has succeeded, and I suspect he can never go back to the US unless he would be willing to face charges (although I'm guessing there). I think he may have felt his life in danger when he first departed.

When I heard about all this a few days ago, I felt the Lord would have me speak to the American about the Lord. I'm not sure how this will come about, or even *if* it will come about, but I will let you know if it does.

I feel my son's well-being is somehow being supported by those of you who pray. Since I posted this thread, he has rais ed the subject of God every time I see him..... which was not his prevous wont.... and despite the latest disturbance to his peace, he seemed to be in generally good fettle emotionally.

As you see, it's a long time since I posted here. A lot of water has flowed under the bridge which partly has been covere d in other posts. Now my son lives in an apartment nearby and I see him more regulary (to pick up his laundry;-) which excuse I enjoy).

One thing which I hadn't appreciated when he was living away from home originally, is that he had a significant difficulty with punctuality at work. Apart from late nights and other juvenile reasons, it slowly dawned on him that his dyslexia mig ht be a contributory factor and he began to mention this at work, but a very large global company is not interested, and h as slowly screwed him down through their disciplinary procedure. By late for work, I mean... late by a minute or two. W hat is confusing to him is that even if he leaves home at the same time every day and follows the same route, the journe y time can vary by 10 minutes. If you imagine what it is to lose track in between every task, every day when getting read y to leave, you can see that this difficulty is beyond Garfield's famous observation 'I don't do mornings'. He doesn't get p aid for the times he's early, and this fact is a large irritation to the literalism of a dyslexic.

Some weeks ago, his employer issued a final warning, against which he appealed, and which Appeal they rejected. At the time, he had not been assessed for his dyslexia for some time (because it's very expensive) but we pulled it together a month ago. However, the person who gave feedback was completely unsympathetic to his motor difficulties, and now we need to seek a medical assessment to refine the meaning of the findings even further.

About ten days ago, he was given notice to attend another meeting which is this week (Wednesday I think) and he fully expects to be given notice to quit. He has been under huge stress these last two years as they have steadily harassed him more and more through the disciplinary system, and I think he would be glad to go. But, he's worked there four year s and they can also refuse to give a reference. Even choosing to take time off because of the stress causes its own difficulties because this firm don't seem to follow the normal sick-pay provision an employee might reaonably expect.

Thus, for those who ever had him on their hearts, I bring this to your attention, that he might be supported through the n ext few weeks.

He is eminently employable, as he's had good training, but he doesn't want to find himself in the pincers of another employer's disciplinary procedures.

One last comment... he tells me he comes on SI sometimes although he is still giving much opposition to the fact of God's existence. I've been able to pray for him more in these last months than I was when I opened this thread. If you decide to post, please be discreet and thank you for your prayers.

He has a right of appeal against his dismissal, and this will be time limited. I'm not sure how short a time but I feel sure he'll appeal.

My wife's father went through a difficult time this past year. He is a janitor at his local Wal-Mart Supercenter. He was incorrectly given "three strikes" within a six week period by the administration of the local store. Once an employee is given three strikes, they are either fired or into a probationary period.

I asked him to write a notarized affidavit concerning these issues. I then wrote a lengthy letter and maile d it (along with the affidavit) to Wal-Mart headquarters in Arkansas. Chris, I appreciate your prayers and that testimony.

There has be a lot going on for both for my son and myself in the last three months, and I wish to slip in this request for him in another matter, and myself also, as they are connected.

In mid-December, when he was unwell - and still employed - I was taking him to the doctor. On the way, I pulled out of a junction to turn right - a turn I've made many times - completely sure the road was clear, but found myself faced with the windscreen steamed up, of which I had not taken enough notice in bright sunlight on my side of the road - but through which I could not see <u>at all</u> as I passed into the shadow on the other side (Remember we drive on the left.) I struck a lar ge child with a glancing blow, and his fall was broken by my wing mirror. We were both shaken, as was his mother, but he walked away with a bruised leg, having been seen at the scene by an ambulance crew.

A police van had stopped behind me when I'd pulled over, and they had called help - which really seemed like the Lord's provision at the time. Later, I gave a full statement after the doctor's appointment. However, my son although a witness, was not asked for a statement. And, until today, I didn't know what he had seen. I won't share that information publicly.

See EDIT in my next post: (To explain the pedestrian lights system... they flash both going towards green and towards r ed; cars take precedence if the walkway is empty; pedestrians are advised not to start crossing duing the flashing phase , unless vehicles are already stopped.)

The police seemed to be keeping in touch with me every three weeks or so, until their file had come back from the prose cutor's office asking for a statement from the victim. I heard no more, and assumed they were still waiting for a final deci sion - which can take up to six months. I thought I knew what was happening - that they would call me if a case was being made of it, so I didn't call them when a longer silence ensued.

This morning, I opened an envelope addressed to someone with a name like mine, but wrongly spelled. I had assumed it was a questionaire from some marketing company - certainly nothing important. But .... it was the Summons. Thus, I have missed important deadlines, and have not yet sought legal advice. The case was to be heard on Friday 29th. (If th is is changed, I will post again.)

Apart from my name incorrectly spelled, other technical details may prove significant to the final outcome. Basically, I ne ed a stay, to get enough information to decide how to plead - *if* this still goes to Court. I'm not sure how far the police can go back and retrace their steps. Tomorrow, I need to be making phonecalls early, as there is work to be done.

Primarily I'm asking for prayer for wisdom and grace to bring glory to God. I'm not sure that in this case, I am required to plead guilty to an offence I may not have committed, notwithstanding I did collide with a pedestrian.

I know this may sound crazy, but this is all good experience, and I know the Lord allowed it to happen for a purpose. I c ould care about many other things - like a crimial record, a large fine, time in jail or community service - but I want to do and be only what is honouring to the Lord in this situation, while there is still a legal process which seeks to be fair. I am not trying to get away with a crime if I've committed one, but I will receive however this falls, from the Lord, and I am tha nkful.

I appreciate you all for reading, listening, praying. Perhaps later in the week, if there's something to report, I will update here.

Tomorrow, and Friday - and possibly in between although not already arranged, my son has interviews with two different companies, and opportunities to sign in with agencies already advertising suitable work.

Your prayerful support of his general success is received with gratitude.

My wife and I will certainly be praying about this situation throughout the day and week. Please keep us updated.

My dad experienced a similar situation some time ago. He was getting ready to pull out from a restaurant's "drive throug h" when a man hit him with a bicycle. This man was driving his bicycle on the sidewalk and rammed into our passenger side of the vehicle. My dad jumped out of the vehicle and made certain that the man was okay. He was fine. My dad c alled the police anyway. My dad was NOT ticketed because the man hit my dad, and it is against the law to ride a bicycle on the sidewalk.

My dad's truck was slightly dented and scratched, but he was more worried about the man. My dad didn't want to press the issue at all. Unfortunately, this man saw this as an opportunity for some quick cash. He found a lawyer and sued my dad. My dad's insurance company didn't think that there was a case because my dad was not really in the wrong.

However, my dad has a mild form of glaucoma, and his peripheral vision is limited. As an honorable and honest man, my dad would certainly admit this in court. Against the wishes of his insurance company, my dad agreed to a small settle ment (of about \$25K). I really didn't want for my dad to settle this matter in such a way, but he felt partially at fault. If his vision was better, he reasoned that he could have seen the man riding down the sidewalk.

Anyway, my dad is an extremely honorable man. He wouldn't lie -- even if it was to protect our family financially. This is a great testimony to our family and friends. It was also a good testimony to the man on the bicycle. In fact, my dad even invited the man over for dinner one night.

I will be praying for this situation. May the Lord give you the favor that you need and allow your relationship with Jesus to shine even in this difficult situation. The Lord bless you and encourage you!

Thanks to Chris, David and Claudette for your comforting words and to all others who are also praying.

Relating to my last post above, I've learned today that I was wrong about the lights flashing for vehicular traffic between green and red. They flash only between red and green - which gives pedestrians longer to complete crossing, but if ther e are no pedestrians using the crossing, permits traffic flow to recommence.

Also this morning I've spoken to all the departments I needed to contact, and will seek legal advice through my motor ins urer.

I have to write to the Crown Prosecution Service formally to ask for the case to be delayed, but it is possible the police w ill withdraw it, because their own documentation is now in my hands, and there is nothing they can do to get it back. It is technically incorrect on several counts including not having taken a statement from my passenger - which in itself might have altered their expectation of a Guilty plea.

The police are consulting amongst themselves with the intention of calling me later today. I don't know what their option s are, but an accurate statement from them would be my first request, along with a witness statement on my side, before they decide whether to proceed.

Progress so far today: wrote and delivered an important letter to the prosecuting authority, and spoke to a man at the traffic control centre who will visit the crossing tomorrow.

He tells me it is not necessary to complete the crossing while the static green man is showing. I countered that with my belief that the traffic controls should not be visible to the pedestrian <u>at all</u>, so as to make it necessary for them to wait un til traffic is slowing at least, or the green man appears, before stepping off the kerb.

I checked that if they change the sequence at all, they will have a record of what it was.

Then, I had a conversation with someone who's been to Court to observe a few times, and was much reassured that I will be able to speak to the Magistrate if I attend, even if I plead Guilty. This has given me courage.

Tonight, I'm going to try to finish all other written presentations, so I can print and deliver them tomorrow.

Thank you all who are praying. I know I'm pulling through, but there are some shakey moments. It is a glory to God that He can lead us through even such deservedly unhappy circumstances.

I have been fined, and Court costs added, to a total of a tenth of the maximum financial penalty available to them, (although costs could have been much more), and my licence will be endorsed with six points. (Twelve points = automatic disqualification. They could have given up to nine, within the sentencing guidelines.) The Magistrate acknowledged the accident itself could have been much worse.
