The pro-death, pro-abortion side is seeking an all-out total victory in the Louisiana case claiming that hospital admitting privileges requirements for abortionists are unconstitutional. They then plan to use this victory to strike down all abortion facility regulation laws in all fifty states. They have already filed lawsuits against five states seeking to do this such as Texas, Louisiana, Indiana, Arizona, and Missouri. They are asking for total victory to increase the number of "infant life" (Gonzales v. Carhart, 2007) deaths and to wipe out all of the gains the pro-life movement has made since 1992 in reducing the number of abortion deaths through education and abortion facility regulation.
