After attempting to politely reason with the police they finally said that if I go to another c orner they will not bother me or give me any problems while preaching the gospel.

When I went to another corner differently officers approached me and said "ThatÂ's it. The cops over there already gave you a warning. Now youÂ're getting cited." When attempting to politely reason again with them they said the same thing; you cannot draw any crowds. I was told that I have freedom of speech but if anyone stops to listen I will be cited. And so I was cited for having listeners.

In a letter I received with my court date it stated that the violating was Â"religious solicitation without proof of ID.Â" (Completely bogus because I was giving away money and they saw my ID.) But of course in court the charge was different; it was Â"violating an anti-noise ordinanceÂ".

However when I tried to take it to trial the prosecution backed out again, just like last time, for lack of evidence. Another court case blown out of the water; two Dallas cases down, one Tyler case to go. (I am so appreciative of all your prayers ! Please keep them coming!)
